CALL TO ORDER

The meeting was called to order by Mr. Dunstan, Chair.

APPROVAL OF MINUTES OF SEPTEMBER 25, 2013 MEETING

ANNOUNCEMENTS

Ed Hillhouse, EWGCOG, advised that a special meeting would be convened in December for the purpose of approving the OneSTL plan. He asked members to tentatively reserve December 11, 2013 as the potential meeting date.

DISCUSSION ITEMS

**One STL Plan Update**

David Wilson, EWGCOG, reported that, pursuant to the Board's request, the comment period for the draft OneSTL plan would be extended through November 1, and he advised that comments could be made on forms available at OneSTL.org or could be given directly to staff via e-mail. He noted that a workshop discussing implementation strategies would occur before EWGCOG's Annual Meeting on November 15, 2013. He concluded that the final draft of the plan would be available prior to presentation at the special Board meeting in December.

**Authorization to Accept Match Funding for Great Streets Initiative Planning**

Paul Hubbman, EWGCOG, summarized staff's recommendation to authorize the Executive Director to enter into agreement with the City of Ferguson to provide matching funds for the West Florissant Avenue Great Streets project, in an amount not to exceed \$96,000.

Motion was made by Mr. Miller, seconded by Mr. Mosley. Motion carried, all voting aye.

**Functional Classification Update**

Lubna Shoaib, EWGCOG, summarized staff's recommendation to make functional classification changes to 20 local roads as referenced. She advised that 12 applications did not meet the necessary criteria and, accordingly, were not being recommended for change at this time.

Motion was made by Mr. Dooley, seconded by Mr. Griesheimer. Motion carried, all voting aye.

**Urban Area Boundary Update**

Ms. Shoaib, EWGCOG, summarized staff's recommendation for adoption of updated urban area boundaries for the St. Louis region.

Motion was made by Mr. Waller, seconded by Mr. Minner. Motion carried, all voting aye.

**Calendar Year 2014 East-West Gateway Budget**

Jim Wild, EWGCOG, summarized the Calendar Year 2014 Budget with expenditures totaling \$22,697,820. He also summarized requested changes to the Position Classification Schedule to the Personnel Plan.

Motion was made by Mr. Dooley, seconded by Mr. Parks. Motion carried, all voting aye.

**Auditors' Report on Financial Statements for Calendar Year 2012**

Ed Hillhouse, EWGCOG, summarized the findings of the 2012 audit conducted by Kerber, Eck & Braeckel and staff's recommendation to approve it.

The final draft of the OneSTL plan is being presented for review and approval by the Board of Directors. The document has been revised from the draft presented at the September Board meeting, based on comments received from Board members and many interested partners.

OneSTL summarizes the work of East-West Gateway and ten consortium partners working together under a grant from the U.S. Department of Housing and Urban Development in partnership with U.S. Environmental Protection Agency and U.S. Department of Transportation.

Our consortium partners, all of whom contributed matching funds to the project, include Applied Research Collaborative (ARC— St. Louis University, Southern Illinois University-Edwardsville, and University of Missouri St. Louis), Citizens for Modern Transit, Metropolitan Equal Housing and Opportunity Council, Focus St. Louis; Great Rivers Greenway District, HeartLands Conservancy, Metro, City of St. Louis, St. Louis County, and Trailnet.

This plan is supported by seventy-five technical plans and reports developed under the grant over the last three years, and a web-based Sustainable Solutions Toolkit, all available at [www.oneSTL.org](http://www.oneSTL.org). Additionally, St. Louis University is hosting a St. Louis Regional Data Exchange, [www.stlouisdata.org](http://www.stlouisdata.org), which was also developed under this partnership. The OneSTL plan is also available for download at [www.oneSTL.org/plan](http://www.oneSTL.org/plan).

OneSTL provides a framework for regional collaboration, and recommends voluntary actions that will help people and governments adapt to the future, as the region responds to changes in the economy, the social needs of various communities, and the importance of safeguarding the area's natural assets of water, air and land. More than fifty partner organizations have already committed to implementing one or more of the voluntary strategies identified in the plan.

**Staff Recommendation:** Staff recommends that the Board of Directors approve OneSTL as a plan to facilitate collaboration and build a prosperous, healthy and vibrant future for the St. Louis region.
