CALL TO ORDER

The Executive Advisory Committee was called to order by Jim Fields, Vice-Chair.

APPROVAL OF MINUTES OF JANUARY 17, 2017 MEETING

DISCUSSION ITEMS

OneSTL Report to the Region

Aaron Young, EWGCOG, provided a history of the plan; discussed the report to the region that highlights projects, initiatives, and resources from across the region; and provided an example of work being done to map the different systems identified through OneSTL. He also noted that a

Regional Sustainability Summit is scheduled for April 5, 2017 at the Eric P. Newman Education Center at Washington University to address goal setting and regional collaboration. The first day of the summit will be a traditional conference with specific goals and topics, and the second day will be a work session to discuss how to achieve regional metrics and goals.

Mary Rocchio, EWGCOG, briefly summarized and explained about the performance indicators that are measured to gauge success of the plan. She encouraged those who were interested in additional information about the plan to visit the website at OneSTL.org for further details.

Jim Wild reported that IDOT is holding a Long Range Transportation Plan Survey as indicated by the flyer circulated to the committee.

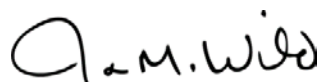

Subject: Draft FY 2018 Unified Planning Work Program
Date: March 14, 2017

We are providing the draft FY 2018 Unified Planning Work Program (UPWP) this month for your review and information. The UPWP describes all of the planning work activities that the staff and other local agencies will undertake during the 12 month period beginning on July 1. The document serves as the scope of work for contracts with the states and federal agencies that provide much of the funding for planning and related activities in the region.

Metropolitan planning organizations are required by federal law to adopt a UPWP every year covering all transportation funded planning activities. Our document includes all of the proposed activities that are planned by staff throughout the agency from all funding sources. Some of the activities described in the UPWP are currently underway and will continue into the next work program cycle and others will start at various times during the year depending on funding availability.

We are projecting new funding for the upcoming fiscal year in the amount of \$10,640,672. The *FY 2018 Funding Summary Chart – New Funding in Period* is shown on page xv of the document. A substantial portion of the projected funding is either passed through or is expended on behalf of other agencies. Our in-house costs for the agency are estimated at \$6,861,000 for the life of the proposed grants.

Over the next month the UPWP will be reviewed and discussed with our funding agencies and participating jurisdictions/agencies. Some of the funding levels shown in the UPWP are estimates and may be revised as more detail is received. We also welcome comments and questions from the Board of Directors. After approval from the funding agencies and input from the Board, we will bring it back to the Board in April for approval.

Subject: Amendment to the FY 2017 Unified Planning Work Program: revision to 2.03 Transportation Improvement Program and Monitoring, 2.11 Multimodal Transportation Planning, 2.12 Great Streets Charrette – Illinois, and 2.13 Great Streets Initiative

Date: March 14, 2017

All planning projects funded with federal transportation dollars are required to be in the Unified Planning Work Program (UPWP). Four work elements require changes to their activities or products, including: 2.03 Transportation Improvement Program and Monitoring, 2.11 Multimodal Transportation Planning, 2.12 Great Streets Charrette – Illinois, and 2.13 Great Streets Initiative. The changes are described below and the revised work elements are attached to this memo.

2.03 – the updated application for STP-S projects (product/outcome J) and a completed TIP database (product/outcome K) have been removed from the FY 17 UPWP because the completion dates for these products/outcomes have been changed to FY 18. Staff continues to work on the updated STP-S application and has developed the evaluation criteria and will be conducting a beta-test of the proposed criteria during FY 17 using information from project applications submitted in March 2017. This beta-test will be used to determine if any changes need to be made to the criteria before the STP-S application is finalized. Staff continues to work on defining the scope for the development of a TIP database and plans to proceed with the build-out of the database in FY 18.

2.11 – the Bicycle Planning Guidance document (product/outcome E) has been removed from the FY 17 UPWP because the completion date has changed to December 2017. The completion date shift will provide staff more time to complete the document and to ensure that the document aligns with the updated STP-S evaluation criteria. Staff will continue to work on the document during the FY 17, but will not have a completed product until December 2017.

2.12 – activities 3 through 6 and products/outcomes B through D related to the consultant procurement, conducting the planning charrette, production of the planning report document, and other associated tasks have been removed from the FY 17 UPWP.

Staff conducted program presentations in Illinois and conducted a call for project applications; however, staff did not receive any project applications for Great Streets planning assistance in Illinois for FY 17. Staff will continue efforts to inform Illinois communities about the Great Streets program and plan to conduct another call for project applications during FY 18.

2.13 – product/outcome A has been revised to reflect the current project schedule for the Forest Park Great Streets project and the major work products that are estimated to be accomplished during FY 17. The planning process will continue through the rest of FY 17 and into FY 18.

These changes do not require a change to the FY 2017 UPWP budget.

Staff Recommendation: Staff recommends that the FY 2017 UPWP be amended to revise the activities or products for elements 2.03 Transportation Improvement Program and Project Monitoring, 2.11 Multimodal Transportation Planning, 2.12 Great Streets Charrette – Illinois, and 2.13 Great Streets Initiative.

Activities:

1. Revise methods for evaluating and prioritizing transportation investments to ensure consistency between the Transportation Improvement Program (TIP), Congestion Management Process (CMP), Regional ITS Architecture and the Regional Transportation Plan (RTP). Research and evaluate methods from other metropolitan areas for applicability to the region.
2. Conduct TIP development workshops to inform local project sponsors and interested parties of project submission requirements and evaluation and approval procedures.
3. Solicit projects and assist local governments and other sponsors in developing and documenting projects for TIP funding consideration.
4. Develop annual list of obligated projects.
5. Maintain and provide staff support to Illinois and Missouri Transportation Planning Committees (TPC).
6. Provide assistance to local sponsors in developing project applications for TIP funding consideration and in implementing projects and maintaining schedules
7. Evaluate projects submitted for TIP consideration and establish funding priorities for local and state highways, transit, paratransit, and transportation alternatives.
8. Define proposed projects and attributes for GIS and database inclusion; evaluate geographic distribution of programmed investments.
9. Perform air quality conformity determinations for the TIP; prepare technical documentation detailing air quality modeling procedures and assumptions, the conformity determinations, and related plan updates; and conduct project-specific air quality analyses, as required.
10. Conduct public outreach to solicit comments on the TIP process and the recommended program.
11. Publish and disseminate TIP, and prepare materials necessary for actions to amend or otherwise revise the TIP, as needed.
12. Conduct project implementation workshops for sponsors with projects in the TIP.
13. Monitor the implementation of TIP projects and track the use of federal funds through the preparation of quarterly progress reports for projects included in the annual element of the TIP with semi-annual reports identifying projects that are failing to meet implementation schedules and falling behind in the obligation of federal funds.

15. Continue development of a process for evaluating the effectiveness of implemented TIP projects. Evaluate “best practices” from other metropolitan areas.
16. Substantiate provisions of annual self-certifications and documentation of performance of the metropolitan planning process, including MoDOT and EWG co-signed annual self-certification statement to be approved by the EWG Board of Directors.
17. Update application for Surface Transportation Program-Suballocated (STP-S) to be consistent with principles and goals of *Connected2045*.
18. Undertake procurement/development of a new database for the development and management of the TIP (*Consultant*).

- B. TIP program development workshops, implementation workshops, and public involvement activities (*ongoing*)

1. Accessibility and Paratransit Planning

- a. Monitor the performance of the transportation system for mobility impaired populations.
- b. Consult and coordinate with mobility impaired advocates to develop funding and project approaches that address access issues.
- c. Compile data on obstacles to access and mobility and prepare informational materials for community education on access/mobility issues.
- d. Develop strategies to create efficiencies in transportation services for the elderly and individuals with disabilities.
- e. Communicate and disseminate paratransit grant information to government, not-for-profit, and for-profit agencies in the region that serve elderly, disabled, and low-income populations in the region.
- f. Assist local sponsors in developing paratransit grant applications.
- g. Conduct a project solicitation, evaluation, and selection process for Section 5310 funds as identified in the Coordinated Human Services Transportation Planning (CHSTP).

2. Bicycle and Pedestrian Planning

- a. Organize regular meetings of and provide staff support to the Bicycle and Pedestrian Advisory Committee (BPAC) and BPAC working groups.
- b. Maintain inventory of local bikeway plans and recommended facilities to support regional bicycle planning efforts.
- c. Implement appropriate strategies from the regional bicycle/pedestrian plan through outreach to local communities and organizations.
- d. Develop a Bicycle Planning Guidance document to assist local governments in developing low stress facilities.
- e. Create and maintain inventory of existing bicycle and sidewalk network in GIS for use in various transportation studies and reports.
- f. Work with local agencies to share information regarding the number of persons using the region's bicycle/pedestrian network. Provide count information to local governments.
- g. Provide technical assistance to local sponsors in developing bicycle and pedestrian projects and applications for TIP funding consideration.

3. **Intermodal Freight Planning**

- a. Provide staff support for the newly created St. Louis Regional Freightway (Bi-State Development Agency).
- b. Continue the process of disseminating the findings and recommendations included in the regional freight study and work with the St. Louis Regional Freightway to implement when possible.
- c. Develop strategies for financing a Regional Rail Network Study in the Region.
- d. Refine the initial baseline assessment of the twenty-three Industrial Site Areas identified in the St. Louis Regional Freight Study.
- e. Provide assistance to state DOT's on regional freight needs, including presentations for DOT sub-groups and affiliated associations.
- f. Coordination meetings with freight community on freight study recommendations.

4. **General Transportation Technical Assistance**

East-West Gateway Council of Governments is requesting to revise the FY 2017-2020 Transportation Improvement Program (TIP), *Connected2045*, and the related Air Quality Conformity Determination to add 20 new projects.

Section 5310

East-West Gateway Council of Governments (EWG) released a solicitation in November 2016 for projects seeking Enhanced Mobility of Seniors and Individuals with Disabilities (Section 5310) Program funding. The Section 5310 Program provides funding to help improve the mobility of seniors and individuals with disabilities by removing barriers to transportation services and expanding the available transportation options. Section 5310 funds are apportioned to the St. Louis, MO-IL Urbanized Area. Approximately \$2.49 million is available for this solicitation. Federal law requires that not less than 55% of the Section 5310 funds be available for the Traditional projects and the remaining 45% may be used for New Freedom Type projects.

Traditional projects include the acquisition of accessible vehicles and related equipment used to transport seniors and individuals with disabilities. New Freedom Type projects include 1) public transportation projects that exceed the requirements of the Americans with Disabilities Act of 1990 (ADA), 2) public transportation projects that improve access to fixed-route service, and 3) alternatives to public transportation that assist seniors and individuals with disabilities. The Section 5310 Program requires a 20% local match for capital and mobility management projects and a 50% local match for operating projects. Eligible sponsors include non-profit organizations, local public entities, and operators of public transportation services.

Section 5310 projects selected for funding must be included in a locally developed, coordinated public transit-human services transportation plan. EWG's Coordinated Human Services Transportation Plan (CHSTP) identifies the transportation needs of

seniors and individuals with disabilities and provides strategies for meeting those needs. The CHSTP was updated and approved by the Board of Directors in June 2016 in accordance with the federal requirements.

Section 5310 applications were due on January 17, 2017. At the conclusion of the solicitation period, EWG staff received 34 Section 5310 applications requesting \$6.343 million in federal funds. Projects proposed for funding were reviewed by EWG staff and evaluated based on the criteria established in the CHSTP. Twenty projects are recommended, totaling \$2.49 million in federal funds. The Section 5310 projects are included in Attachment A.

Staff Recommendation: Staff recommends that the FY 2017-2020 TIP, *Connected2045*, and the related Air Quality Conformity Determination be revised to add 20 new Section 5310 projects as detailed in Attachment A. These projects are exempt with respect air quality in accordance with federal regulations (40 CFR 93.126).

Subject: Regional Security Expenditures
Date: March 14, 2017

Staff is requesting authorization to expend funds in support of regional security that will improve the region's disaster preparedness and response capabilities. Funding will come from the U.S. Department of Homeland Security's Urban Areas Security Initiative (UASI) and the Assistant Secretary of Preparedness and Response (ASPR) Hospital Preparedness grant programs. Attachment A summarizes this purchases totaling **\$96,428**. Also attached is a summary description of all budgeted expenditures from the UASI grants (Attachment B).

- 1. Hospital Emergency Radio Communications** – In 2016 STARRS purchased desktop and portable handheld radios for the Missouri hospitals in the St. Louis region. These interoperable radios are currently being used by hospital emergency departments and incident command centers to coordinate regional emergency events with the St. Louis Medical Operations Center, local EMS and county emergency management agencies, as well as various regional partners. The radios function on the St. Louis Area Regional Trunk Radio (SLATER) system. In order to expand their capability during a statewide disaster response, there is a need to reprogram the radios so they can function on the Missouri Statewide Interoperability Network (MOSWIN). Programming will include MOSWIN radio talk group and control functionality assignments, and software upgrades that are necessary for the radio to operate on the MOSWIN network. Therefore, we are requesting approval to expend funds to support the programing of 166 radios to function on the MOSWIN network. Total cost will not exceed **\$14,000**.
- 2. IBM Statistical Package for the Social Sciences (SPSS) Software** – We are requesting approval to purchase seven authorized base SPSS user licenses and seven regression SPSS user licenses for the St. Louis regional local public health agencies. SPSS is an IBM software program which manages an analytical process. It allows public health epidemiologists to analyze the various types of data that is routinely collected when conducting syndromic surveillance, especially during outbreaks. It will be used for response to a communicable disease outbreak, pandemic influenza, or biological attack incident. This purchase would ensure uniformity in data visualization capacity for epidemiologists across the region. The SPSS user licenses

will be distributed to the East Side Health District and to the Madison, and St. Clair County Public Health Departments in Illinois and in Missouri to the City of St. Louis, Franklin, Jefferson and St. Louis County Public Health Departments. Total cost will not exceed **\$27,993**.

3. **Law Enforcement Tactical Robot** – Last month’s Regional Security Expenditure memo included the purchase of Mini-Caliber Tactical Robots for five law enforcement agencies in the region. We are requesting approval to add an additional Mini-Caliber robot for the St. Clair County, Illinois Sheriff’s Department. The additional cost is **\$54,435** which increases the total cost not to exceed to \$326,610 for six robots.

The purchases described in this memo are being made in accordance with the agency’s procurement policy.

Staff Recommendation: Staff recommends that the Board approve the expenditure of funds as follows:

- to allow the Executive Director to enter into a contract with WirelessUSA for the programming of 166 hospital radios in an amount not to exceed **\$14,000**;
- for the purchase of seven (7) authorized base user licenses and seven (7) regression user licenses from PCM-G/Global GovEd in an amount not to exceed **\$27,993**; and,
- or the purchase of a Mini-Caliber SWAT Robots from ICOR Technologies, Incorporated in an amount not to exceed **\$54,435**,

for a total amount not to exceed **\$96,428** from the UASI and the ASPR Hospital Preparedness grant program.
