CALL TO ORDER

The Executive Advisory Committee was called to order by Vice Chair Jim Fields.

APPROVAL OF MINUTES OF JULY 22, 2014 MEETING

Motion was made by Mr. Hutchings, seconded by Mr. Elmestad, to approve the minutes of the July 22, 2014 meeting. Motion carried, all voting aye.

DISCUSSION ITEMS

Where We Stand Update: Racial Segregation and Disparity

John Posey, EWGCOG, advised that staff completed a comparative analysis of racial segregation and disparity in the St. Louis region. He advised that the report, not yet available, would be released and discussed in greater detail at the Board of Directors Meeting on September 24, 2014.

Great Streets Initiative: West Florissant Avenue Corridor Planning and Development Effort

Paul Hubbman, EWGCOG, summarized the West Florissant Avenue Great Streets Initiative, described the area studied in the plan, challenges that have been identified in creating a "roadmap" for the area, and what the overall plan would include. He advised that a working group has been formed to support the implementation of recommendations in the corridor and will remain in place after completion of the plan to provide technical assistance and help foster strategic partnerships. He noted that the plan is available on EWGCOG's website.

Additional discussion followed regarding recognized benefits of the project, and overall safety concerns and benefits of the renewed corridor.

Strategic Action Plan for Saint Louis' Regional Freight Partnership

Jim Wild, EWGCOG, provided a history of the planning process leading up to formation the Freight Working Group and development of the Strategic Action Plan.

Jason Carter, AEGIS, followed with a presentation summarizing elements of the plan developed as Phase I of the Regional Freight Partnership. The overall goal of the final plan is to expound on various forms of freight in the region to enhance local economic development. He summarized the structural models used by the working group to tailor a plan, and reviewed some of the gaps and required capabilities that were identified. He described the new entity (America's Gateway), that would be formed, under Bi-State Development Agency's control, and he described some its functions toward improving and building freight infrastructure in the region. Mr. Wild added that the Board of Directors would be asked to approve moving forward with Phase 2, which includes hiring personnel.

Mr. Wild advised that the cost to staff and run the organization would be about \$800,000 a year, and he described potential funding sources to meet those needs.

Additional discussion followed regarding other entities' roles in establishing freight priorities; the feasibility of including language in the plan that would reflect how residential neighborhoods would be impacted and accommodated; and timeframe for formation of America's Gateway.

Subject: Pathway to Public Office Workshop

October 14, 2014

At the September meeting of the East-West Gateway Board of Directors staff was directed to create programming on the process involved in running for public office. The need for this type of effort is borne out of recent conversations stemming from the events in Ferguson and regional discussions about racial disparities in representation on elected boards across the region. In order to get more interested people into elected and appointed service, it was posited that there needs to be an opportunity for discussion and information dissemination around why public office is a path worth pursuing, what potential candidates should expect and what they need to know about the process.

Working with the Local Government Partnership, Council staff is designing, organizing and offering a one-day, free workshop on Saturday, December 6, 2014 at the University of Missouri - St. Louis (UMSL) that will be open to anyone who is interested in running for public office. The Local Government Partnership is a cooperative effort of East-West Gateway Council of Governments, the Public Policy Administration Program at UMSL and the Center for Ethics in Public Life at UMSL that leverages the resources of these organizations to provide training and technical assistance to local governments and those interested in local government in the St. Louis region. The initial workshop will be geared toward potential candidates for non-partisan posts in Missouri - municipal, school district, and fire district boards. The experience with this workshop can inform a decision to offer a workshop appropriate for Illinois potential candidates at a later date.

In addition to the goal of offering a workshop during this March/April election cycle, East-West Gateway staff met with organizations and individuals in the region who work on pipeline to public office and leadership programs, who have a mission-driven interest in local government or who are involved in voter/election information and education. There is an interest among these organizations in a longer-term discussion on coordinating efforts to create a set of activities and resources around these issues beyond the 2014 workshop. We will continue to identify and pursue these opportunities.

The Missouri Department of Transportation (MoDOT) and St. Charles County are requesting to revise the FY 2015-2018 TIP, *RTP 2040*, and related Air Quality Conformity Determination to add six new projects.

(TIP) – Requested by Missouri sponsors

Modification of the FY 2015-2018 Transportation Improvement Program

New Projects

MoDOT Projects

MoDOT is requesting to add a pavement improvement project on I-64 in St. Charles County at a total cost of \$217,000. MoDOT is also requesting to add a bridge painting project for three bridges on MO 21 in Jefferson County at a total cost of \$326,000. These projects will be funded using cost savings from other projects already completed in this fiscal year.

St. Charles County Projects

St. Charles County is requesting to add one bridge removal project and three bridge replacement projects. These projects are funded through the Off-System Bridge Program (BRO). BRO funds are allocated to a county based on the square footage of locally maintained deficient bridges within the county.

St. Charles County will remove one bridge on Old Highway Z near Wentzville at a total cost of \$50,000. This bridge is located just north of a dead-end and will not impact travel as MO Z parallels Old Highway Z. They will also replace bridges on Schnarre Road, Nahm Road, and South Shore Drive. Each bridge replacement has a total cost of \$300,000.

Staff is recommending approval of an update to the functional classification system for the region. Functional classification is the process by which all roadways are grouped into classes according to the type of service they provide. The Federal Highway Administration (FHWA) requires the use of functional classification to determine eligibility for federal funding. There are three principal roadway classifications: arterial, collector, and local roads. Any roadway classified as a rural major collector/urban collector or higher is eligible for federal funds.

In order to accurately reflect changes in land use and travel patterns, staff, along with MoDOT and IDOT, solicits revision applications from member agencies semi-annually and conducts a full system review every three to five years. County and municipal officials submitted applications requesting functional class changes to East-West Gateway during the month of May 2014. Staff worked with MoDOT, IDOT and local officials to prepare this recommended update.

The applications were reviewed in the context of FHWA guidelines, which include mobility, accessibility, and connectivity criteria. Staff also visited sites to verify conditions. Requested changes are recommended where it is deemed that a road's current classification is no longer consistent with its function. In some cases, it was found that current conditions did not support a change in classification as requested.

At this time, a total of 12 changes are recommended to the system. One (1) application is not recommended because it does not meet the criteria for a change in classification. A list showing the recommended changes is attached with a set of maps.

Once approved, the update will be sent to MoDOT and IDOT headquarters for final review and subsequent submittal to FHWA for approval.

Staff Recommendation: Staff recommends adoption of the functional classification update for the St. Louis region as shown in the attached list and maps.





Map 4 - City of Herculaneum, MO





Map 5 - City of Wentzville, MO





Map 6 - City of Weldon Spring, MO



Revision to East-West Gateway Council of Governments Retirement Savings Plan

October 14, 2014

The East-West Gateway retirement plan is a defined contribution 401(k) plan. The Council currently matches voluntary employee contributions to the 401(k) plan up to the maximum of 4.25% of annual salary. The maximum match percentage of 4.25% was established in 1985 when the 401(k) plan was adopted and contained a step provision based on years of service. The step provision limited match to fifty percent of employee contribution if they had less than four years of service. The only change to employer match since the inception of the plan has been the elimination of the step provision in 1990.

A recent review of the plan conducted by the Retirment Plan Advisiory Committee revealed that only nine percent of our employees are on track to meet the recommended target income replacement upon retirement. After a review of public employer retirement benefits provided in the area, we feel that our current match is well under the benefits offered by public employers in the area.

We are recommending that the Council's maximum match percentage be increased to six percent effective Janaury 1, 2015. We estimate that the maximum cost of this increase will be \$50,600 in 2015. The net impact to the surplus for 2015 is estimated to be \$8,350 with the balance of \$42,250 provided from the Council's federal and state grant funds. East-West Gateway does not provide a pension plan for its employees and therefore has no unfunded pension liability.

<u>Staff Recommendation</u>: Increase the 401(k) discreationary match provided by East-West Gateway from 4.25% to 6% effective January 1, 2015.

The agency budget will be considered at the upcoming annual meeting by the membership of East-West Gateway, following a recommendation by the Board of Directors. Attached is the Council's proposed budget for the year beginning January 1, 2015. We are proposing a budget of \$8,823,950. Approximately twenty-six percent of this budget will pay for public safety planning, equipment, software and training that will be provided to our member local governments and area first responder entities. An additional eight percent, for transportation, economic development, and environmental work, will be passed through to other public agencies and planning consultants. The Council's staff and operating costs is projected to be approximately \$5.5 million.

Calendar Year 2015 East-West Gateway Budget

East-West Gateway's budget includes expenditures for work activities included in the FY 2015 Unified Planning Work Program, as well as those activities anticipated to be in the FY 2016 UPWP. We've estimated funding for the Highway Transportation Planning, Environmental, Bioterrorism Hospital Preparedness, and Urban Area Security Initiative programs. Match for the Highway Transportation Planning and Environmental initiatives in the amount of \$668,000 will be provided in the form of cash or in-kind contributions from state and local agencies.

The funds received from the transportation project assessment fee, and the per capita contribution by member counties will be primarily utilized as match for the federal transportation funds. The voluntary contribution by member counties will remain at 12.5 cents per capita. The contribution represents less than four (4.0) percent of the budgeted agency resources for 2014.

Salaries and benefits totaling approximately \$4,822,000 include funding for 59 full time employees (FTE) compared to the estimated 56 FTE for 2014. The proposed budget also includes a cost of living adjustment (COLA) of 2% for all employees, a 1% raise based on merit, and a projected increase in health insurance of 12.5%. The COLA and merit raise, along with the associated incremental benefits are projected to cost \$128,000. We estimate that the net impact to the surplus for 2015 is \$21,100 and the balance of \$106,900 would be provided from the federal, state and other grant funds.

2015 Aerial Photography Project

October 14, 2014

In 2011 East-West Gateway and STARRS' staff began working on a regional map that would enhance emergency response capabilities by providing a base map for the Enhanced 911 (E-911) systems across the region. A key element in modernizing emergency response is the switch to enhanced E-911. The shift from traditional 911 services to E-911 requires operators to respond to emergency calls from mobile devices, which in turn will require that each county public safety answering points (PSAP) have access to geographic information in adjacent counties. Several of the counties in the St. Louis region either have or will be implementing E-911 systems for their jurisdictions. In October of 2011 staff received approval to expend funds to hire a company that would provide aerial photography of the region at a high resolution and scale that is required for a project of this magnitude. Once the aerial photography work was completed updated maps were distributed throughout the region.

It has now been over two years since the initial aerial photography work was completed and, in order to facilitate the development of a consistent, regional map that contains data for all eight counties, East-West Gateway needs to update the aerial photography by performing another photo flight of the region. The success of the aerial photography project also requires a comprehensive quality assurance / quality control (QA/QC) program. During the prior project, the United States Geological Survey (USGS) partnered with East-West Gateway and provided the QA/QC program. USGS is no longer partnering with local agencies to provide these types of services; therefore, we must hire an independent third-party contractor to implement the QA/QC program for this project.

In order to achieve the project's goals, two requests for proposals (RFP) were issued in September and proposals were received on October 1, 2014 - - one for the Aerial Imagery and one for the QA/QC for the aerial imagery. We received three responsive proposals for the imagery RFP and two responsive proposals for the QA/QC RFP.

A selection committee evaluated, scored, and ranked the proposals for both elements of the project. After completion of the evaluation process the firms listed below received the highest rank from the committee and were selected as the firms to be recommended for contract award.

- Surdex Corporation was selected for the Aerial Imagery work because of its experience completing projects of the scope and magnitude of the St. Louis project and because of its experience working in, and knowledge of, the St. Louis region and conditions that may affect the project.
- GRW Aerial Surveys, Inc. was selected for the QA/QC work because of its extensive experience performing QA/QC work, its expertise in providing the requested services, and its understanding of the project scope.

Lincoln County, Missouri – As in the prior project, Lincoln County, Missouri has asked to participate in the current aerial photography project. Lincoln County will pay for the costs associated with completing the aerial photography and the QA/QC in Lincoln County. UASI grant funding will not be used to cover the costs of the Lincoln County imagery or QA/QC. Lincoln County, if included in the project, will provide local funds to cover the costs of the Lincoln County imagery and QA/QC. East-West Gateway will enter into a funding agreement with Lincoln County for an amount not to exceed a total of **\$79,982.**

 4^{th} Band Data – As part of the aerial imagery acquisition, Surdex Corporation will capture 4^{th} band data, which includes multi-spectral (Red, Green, Blue or "RGB") and near-infrared / color infrared or "NIR/CIR" images. This data is used to conduct land cover refinement analysis for East-West Gateway's Long Range Transportation Plan. The 4^{th} band data processing will be included as an option in the Surdex contract. The 4^{th} band data processing will not be supported with UASI funds. The cost of the 4^{th} band data will be covered by East-West Gateway's MoDOT/IDOT Planning funds. The total cost of the 4^{th} band data processing will not exceed a total of **\$8,950**.

Total Project Costs – The maximum total cost for the aerial photography project is **\$646,800**, which includes Lincoln County and the 4th band data. The costs for the project will be paid for out of following sources: (1) a maximum amount of **\$596,960** from the UASI grant; (2) a maximum of **\$8,950** from East-West Gateway's MoDOT/IDOT Planning funds; and (3) a maximum total of **\$79,982** from Lincoln County local funds.

Staff Recommendation: Staff recommends that the Board of Directors authorize the Executive Director to: (1) enter into an agreement with Surdex Corporation for the aerial imagery for a cost not to exceed **\$581,950**, which includes Lincoln County and the 4th band data; (2) enter into an agreement with GRW, Inc. for a cost not to exceed **\$64,850**, which includes Lincoln County; and (3) enter into an agreement with Lincoln County to provide local funds in an amount not to exceed **\$79,982**.
