CALL TO ORDER

The Board of Directors meeting was called to order by the Mr. Kern, Chairman.

APPROVAL OF MINUTES OF MAY 29, 2019

Motion approving May 29, 2019 Meeting Minutes made by Mr. Mosley, seconded by Mr. Reed. Motion carried, all voting aye.

DISCUSSION ITEMS

Community Innovation and Action Center

Paul Sorenson, UMSL's Community Innovation and Action Center, informed the committee that the Center is the result of a merger between the Public Policy Research Center and the social entrepreneurial organization called Social Innovation St. Louis and will carry on some of the community engagement and socialization work of those two organizations. He then introduced the St. Louis Regional Data Alliance (RDA). The primary mission/work and focus of the RDA is intended to build a strong and strategic regional data community, identify and organize existing community datasets, and create and sustain new primary datasets/data tools/data standards as a free data repository for publicly available data in the St. Louis region. A July 2019 launch is planned with pilot St. Louis City and St. Louis County data. The Center is seeking data professionals who would be helpful in this volunteer endeavor. Mr. Sorenson noted that if anyone was interested in receiving additional information, or to subscribe to their newsletter, they could contact him using the contact information provided.

Draft FY 2020-2023 Transportation Improvement Program (TIP) and Regional Air Quality Conformity Determination

Jason Lange, EWGCOG, briefly described the process, strategies and schedule of the TIP and how federal funds are allocated to transportation projects, and noted that the draft FY 2020-2023 TIP has been developed using priorities, procedures, and policies previously approved and adopted by the Board. Staff has worked with project sponsors, funding agencies, and advisory committees to develop the recommended program of projects. He highlighted summaries for the Total Program, IDOT, MoDOT, Transit, Local Programs and Major Projects, and the Fiscal Constraint, Air Quality Conformity Analysis, and Public Participation locations and schedules. Mr. Lange indicated the IDOT program had not yet been released by the Governor, therefore it is not included in the Draft TIP. Staff will continue to monitor and add IDOT programs once released. Following the public meetings in July, staff will bring the Final FY 2020-23 TIP and

Air Quality Conformity Determination to the board in August for final approval. All documents are available on the EWGCOG website.

Introduction

Following the Discussion Items, Chairman Kern introduced and welcomed James Knowles III, Mayor of Ferguson, as the newest member of the Board of Directors.

ACTION ITEMS

Approval of the Final Air Quality Conformity Determination and Documentation and Adoption of the Long Range Transportation Plan Update, *Connected2045 and State of the System Technical Supplement*

Peter Koeppel, EWGCOG, gave a briefing on *Connected2045* and the *State of the System Technical Supplement* noting that the region's long-range transportation plan is updated every four years, all transportation projects using federal funds must be identified in the long-range plan or be consistent with the plan's principles. He further pointed out that the State of the System Technical Supplement to *Connected2045* details the analysis for the plan's development and highlights the Council's transportation planning activities. Mr. Koeppel noted that staff conducted an Air Quality Conformity Determination as part of the development of *Connected2045* in accordance with the Clean Air Act Amendments of 1990 and related Federal regulations. Both the *Connected2045* and State of the System were previously presented to the boards as well as two open houses (one each in Illinois and Missouri) to solicit comments from the public; documents are available for review and downloading on the EWGCOG website. Staff recommends approval of the *Air Quality Conformity Determination and Documentation (8-Hour Ozone)* for *Connected 2045* and the Long-Range Transportation Plan, *Connected2045*.

Motion approving the recommendation was made by Mr. Mosley, seconded by Mr. Reed. Motion carried, all voting aye.

Extension of September 30, 2019 Suspense Date for Locally Sponsored Projects

Josh Schwenk, EWGCOG, pointed out that the board previously approved a policy regarding a one-time schedule change which would allow sponsors to request, no later than June 3, a one-time extension, three-month extension, or nine-month extension to project schedules. He noted that as of the June 3rd deadline, staff received 13 eligible requests for nine-month schedule extensions beyond the September 30, 2019 suspense date totaling \$13.4 million in federal funds. He further noted that the remaining 54 projects with construction funds programmed in FY 2019 (\$33.1 million in federal funds) have obligated funds or are on schedule to obligate funds by September 30, 2019. Staff recommends granting a nine-month extension to the September 30, 2019 suspense date to the 13 projects; federal funds for these projects must be obligated no later than June 30, 2020.

Motion approving the recommendation was made by Mr. Mosley, seconded by Mr. Reed. Motion carried, all voting aye.

Consultant Selection for Frenchtown – City of St. Charles Great Streets Planning

Jerry Blair, EWGCOG, pointed out that the next planning effort for the Great Streets Initiative is the Frenchtown area in the City of St. Charles, MO and also noted that this is the first great streets initiative occurring in the St. Charles area. The Council solicited consulting services for the study, and after releasing the RFP received proposals from eight consulting teams. A selection committee representing the City of St. Charles, St. Charles County and the Greater St. Charles County Chamber, and the Council reviewed and scored proposals subsequently accepting the proposal from Design Workshop. Staff recommends that the Executive Director be authorized to negotiate and enter into a contract with Design Workshop; in the event that the Council cannot reach agreement with Design Workshop, staff recommends the Executive Director be authorized to negotiate and enter into a contract with SWT Design. Staff also recommends that the Executive Director be authorized to enter into funding agreements with the City of St. Charles and St. Charles County for the required 20% match funding.

Motion approving the recommendation was made by Mr. Gannon, seconded by Ms. Krewson. Motion carried, all voting aye.

Modifications of the FY 2019-2022 Transportation Improvement Program (TIP), Connected2045, and the Related Air Quality Conformity Determination – Requested by Illinois and Missouri Sponsors

Josh Schwenk, EWGCOG, summarized requests made by the Illinois Department of Transportation (IDOT), Missouri Department of Transportation (MoDOT), and the Village of Godfrey to add eight new projects, modify three existing projects, and add nine scoping projects.

Metropolitan Transportation Planning Process Certification

Appendix A of the Transportation Improvement Program (TIP) document contains the Metropolitan Transportation Planning Process certification. This certifies that East-West Gateway of Governments (the Council) meets the requirements of 23 CFR §450.336 and must be signed by the Council, Missouri Department of Transportation (MoDOT), and Illinois Department of Transportation (IDOT). It must also be approved by Federal Highway Administration (FHWA) and Federal Transit Administration (FTA). The certification is part of the TIP document. The certification language may be found in **Attachment A** of this memo.

Air Quality Conformity Analysis

Since the St. Louis region is designated as a non-attainment area for air quality, the TIP must be analyzed to determine its conformity with air quality plans and objectives. Staff completed this analysis prior to the draft TIP being presented to the EAC and Board of Directors in June. Subsequent TIP modifications were determined to have no impact on the conformity finding. The projects in the proposed transportation program meet the applicable air quality conformity requirements.

FY 2020-2023 Transportation Improvement Program

Each year the Board of Directors adopts a TIP that allocates federal funds to transportation projects. The program comprises the first four years of projects and strategies in the regional long-range transportation plan. Before a project is eligible to receive federal funds it must be included in the TIP.

The FY 2020-2023 TIP has been developed using priorities, procedures, and policies approved by the Board of Directors through the adoption of the long-range transportation plan, *Connected2045*. Staff has worked with project sponsors, funding agencies, and advisory committees to develop the recommended program of projects.

Total Program Summary

The FY 2020-2023 TIP contains 735 new and previously programmed projects totaling nearly \$2.53 billion. The majority of these projects (542) are currently programmed in the FY 2019-2022 TIP and presented for reprogramming with some adjustments. All of the projects proposed by sponsors to retain their program status are recommended for reprogramming.

The FY 2020-2023 TIP differs slightly from the draft TIP that was submitted for public comment. Twenty-two projects have been added and six projects have been removed, which yields a net increase of 16 projects. Twenty-three projects have been modified. These changes are reflected in the table below by program and detailed in **Attachment B**.

IDOT Program Summary

IDOT's program contains eight reprogrammed or rescheduled projects at a total cost of \$82.2 million. The Governor of Illinois has not released the IDOT program at this time. The eight projects included in the FY 2020-2023 TIP were included in the FY 2019-2022 TIP and are scheduled for letting through March 2020 in FY 2020.

MoDOT Program Summary

MoDOT's program contains 211 projects at a total cost of \$1.25 billion. This includes 127 reprogrammed or rescheduled projects and 84 new projects.

Seventy-three percent of MoDOT's program is for preserving the existing infrastructure and three percent is for capacity adding projects. Fourteen percent of the program is for operational and safety needs. Another nine percent of MoDOT's total program is allocated for projects such as studies or payback projects, including GARVEE bonds for the Mississippi River Bridge, Safe and Sound, and the I-64 reconstruction. The remainder (one percent) includes work specifically related to pedestrian improvements.

Transit Program Summary

In Missouri and Illinois, 156 transit projects (146 reprogrammed and 10 new) were submitted for programming. The total cost of the transit projects is \$655.1 million.

Bi-State Development/Metro's program consists of 97 projects at a total cost of \$585 million, while the program submitted by the Madison County Transit District contains 17 projects at a total cost of \$65.4 million. Most of the funding in Metro's and Madison County Transit District's programs comes from FTA Section 5307 funds.

The other 35 projects in the transit program (\$4.7 million) consist of Section 5310 (Enhanced Mobility of Seniors and People with Disabilities), Section 5316 (Job Access and Reverse Commute), and Section 5317 (New Freedom) projects.

Summary of Local Programs

The local Illinois program contains 112 projects (85 reprogrammed and 27 new) at a total cost of \$130.2 million. The 27 new projects have a total cost of \$21.1 million (\$14.7 million in federal funds).

The local Missouri program contains 248 projects at a total cost of \$410.1 million. Included are 176 reprogrammed projects and 72 new projects. The 72 new projects have a total cost of \$147.7 million (\$87.9 million in federal funds).

Financial Capacity

The TIP is required to be fiscally constrained, with reasonable assurance that funds will be available to implement the proposed projects in a given year. Staff has evaluated the federal funds programmed in the TIP with regard to amounts authorized in federal legislation and anticipated federal spending limitations. The proposed federal funding levels for the entire program do not exceed the funds anticipated to be available in the various program years.

The state DOTs, transit agencies, and local sponsors have incorporated inflation factors into the cost estimates for their projects that are expected to be implemented beyond the first year of this TIP. Further, each of the local implementing agencies has submitted written certification indicating that non-federal matching funds are available for their respective projects. In this way, there is some assurance that proposed projects represent true commitments on the part of local agencies rather than project "wish lists."

Public Participation

The draft TIP and Air Quality Conformity Determination were circulated for public comment from June 28 through August 5 and were presented at five open house meetings in July. The locations and dates for the open house meetings were posted on the Council's website, in the Council's *Local Government Briefings* newsletter, on the Council's Facebook and Twitter page, and advertised in local newspapers. Copies of the draft TIP and the Air Quality Conformity Determination, as well as supplemental materials such as maps and charts, were provided at the open house meetings for review and discussion. Council staff and representatives of the state DOTs, transit service providers, and local project sponsors were available to provide information and answer questions from citizens, members of organizations, and elected officials.

A summary of the public comments received is included in **Attachment C.** Also, staff has assembled a separate *Summary of Public Comments* document that contains all of the comments received during the public comment period and details attendance at each of the five open house meetings. Comments received to date mainly support projects in the FY 2020-2023 TIP and Air Quality Conformity Determination. Staff does not recommend any changes to these documents based on these comments.

Attachment A

METROPOLITAN TRANSPORTATION PLANNING PROCESS CERTIFICATION

In accordance with 23 CFR § 450.336, the Illinois Department of Transportation, the Missouri Department of Transportation, and the East-West Gateway Council of Governments (EWGCOG), the Metropolitan Planning Organization for the St. Louis urbanized area, "certifies" that the transportation planning process is addressing the major issues in the metropolitan planning area and is being conducted in accordance with all applicable requirements of:

- 1. 23 U.S.C. § 134, 49 U.S.C. § 5303, and 23 CFR Part 450 Subpart C;
- 2. Sections 174 and 176(c) and (d) of the Clean Air Act, as amended (42 U.S.C. §§ 7504, 7506(c) and (d)) and 40 CFR Part 93;
- 3. Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C. § 2000d et seq.) and 49 CFR Part 21;
- 4. 49 U.S.C. § 5332 prohibiting discrimination on the basis of race, color, religion, national origin, sex, disability, or age in employment or business opportunity;
- 5. Section 1101(b) of the Fixing America's Surface Transportation (FAST) Act (Pub. L. No. 114-357) and 49 CFR Part 26 regarding the involvement of disadvantaged business enterprises in U.S. DOT funded projects;
- 6. 23 CFR Part 230, regarding the implementation of an equal employment opportunity program on federal and federal-aid highway construction contracts;
- 7. The provisions of the Americans with Disabilities Act of 1990 (42 U.S.C. § 12101 *et seq.*) and 49 CFR Parts 27, 37, and 38;
- 8. The Older Americans Act, as amended (42 U.S.C. § 6101 *et seq.*) prohibiting discrimination on the basis of age in programs or activities receiving federal financial assistance;
- 9. Section 324 of the Title 23 U.S.C. regarding the prohibition of discrimination based on gender; and
- 10. Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. § 794 *et seq.*) and 49 CFR Part 27 regarding discrimination against individuals with disabilities.

EWGCOG is exempt from the requirements of 23 U.S.C § 134(d)(2) and 49 U.S.C. § 5303(d)(2), as amended by the FAST Act §§ 1201 and 3003 because: (1) EWGCOG operates pursuant to the Missouri State and Regional Planning and Community Development Act (Mo. Rev. Stat. Chapter 251) and the Missouri Nonprofit Corporation Act (Mo. Rev. Stat. Chapter 355), which were both in effect on or before December 18, 1991; (2) these Missouri laws have not been amended after December 18, 1991, as regards EWGCOG's structure or organization; and (3) EWGCOG has not been designated or re-designated after December 18, 1991.

Subject: Additional Services for Frenchtown Great Streets planning

Date: August 14, 2019

In 2006, the Council launched the Great Streets Initiative, encouraging communities to incorporate a wide range of issues and goals for their significant streets through planning assistance. Council staff identified the Frenchtown area in the City of Saint Charles, Missouri for Great Streets Initiative planning, consistent with the Council's Unified Planning Work Program. In April, the Council issued a request for proposals (RFP) to hire a consultant to provide planning services for the Frenchtown Great Streets project with an option to conduct an additional market analysis.

In June the Board authorized the Executive Director to enter into an agreement with Design Workshop to provide planning services for the Frenchtown Great Streets Project and to enter into agreements with the City of St. Charles and St. Charles County to provide the local match for the Great Streets planning effort. Subsequent to the Board's action, the City of St. Charles and St. Charles County requested that an additional market analysis be conducted at two target intersections adjacent to the Great Streets project area. The City of St. Charles and St. Charles County have agreed to provide the funding required to complete these services.

The Council will be the responsible contracting party.

Staff Recommendation: Staff recommends that the Executive Director be authorized to include the additional market analysis in its contract with Design Workshop, for an amount not to exceed \$30,000.

Staff also recommends that the Executive Director be authorized to accept funding from the City of Saint Charles and Saint Charles County for these additional services through the funding agreements and in an amount not to exceed \$30,000.

Date: August 14, 2019

Staff is requesting authorization to expend funds in support of regional security that will improve the region's disaster preparedness and response capabilities. Funding will come from the U.S. Department of Homeland Security's Urban Areas Security Initiative (UASI) grant program. Attachment A summarizes these expenditures totaling \$171,614. Also attached is a summary description of all budgeted expenditures from the UASI grants (Attachment B).

Project Manager for St. Louis Regional License Plate Recognition Database (LPRD) and Mugshot Recognition Technology (SMRT) Databases – The Project Manager for the LPRD and SMRT is a part time position within the St. Louis Fusion Center. The position facilitates and oversees the implementation of the regional law enforcement license plate reader and mugshot recognition databases. The city of Richmond Heights Police Department has agreed to provide the LPRD/SMRT Project Manager on a part time basis and the city of Richmond Heights agreed to accept a subgrant award for the funding.

In May staff requested approval to continue funding the LPRD/SMART Project Manager within the St. Louis Fusion Center and the Board authorized a sub-award to the city of Richmond Heights for an amount not to exceed \$43,982. Staff was recently notified that the position's hourly rate had changed and the sub-award needs to be amended to increase the total amount awarded to the city of Richmond Heights. Therefore, we are requesting approval to amend the sub-award to the city of Richmond Heights to increase the award amount by \$7,632 for a new total not to exceed \$51,614, for the period of July 1, 2019 through June 30, 2021.

St. Louis Regional Cybersecurity Coordinator – The Presidential National Security Strategy identified cybersecurity as a leading challenge to national security, today and in the future. Additionally, the regional Threat and Hazard Identification and Risk Assessment has identified major gaps in the cyber realm and the U. S. Department of Homeland Security (DHS) requires that recipients of DHS grant funding must fund a cybersecurity initiative.

To that end, the St. Louis Regional Cybersecurity Coordinator position will address identified gaps and deficiencies in St. Louis Regional cybersecurity, reduce the region's threat landscape, enhance the overall security posture, and improve response, mitigation, recovery, and resiliency to any major cyber-attack. Additionally, the Coordinator will work closely with cybersecurity specialist within the Missouri Office of Homeland Security, the FEMA cybersecurity advisor, the United States Secret Service and the Federal Bureau of Investigation. The position's number one job task will be securing election systems, conduct regional cyber training and exercises, and promote cyber security practices to the region's stakeholders.

Therefore, we are requesting approval to enter into an agreement with the city of St. Louis to provide funding to support the St. Louis Regional Cybersecurity Coordinator position within the St. Louis Fusion Center. The total cost for salary and benefits for the Cybersecurity Coordinator position will not exceed \$120,000 for the period of October 1, 2019 through September 30, 2020.

All expenditures described in this memo are being made in accordance with the agency's procurement policy.

<u>Staff Recommendation</u>: Staff recommends that the Board approve the expenditure of funds as follows:

- to amend the sub-award to the city of Richmond Heights, Missouri for the Automated License Plate Reader and Mugshot Recognition Technology System Project Manager to an amount not to exceed \$51,614; and,
- for a sub-award to St. Louis City, Missouri for the St. Louis Regional Cybersecurity Coordinator position in an amount not to exceed \$120,000;

for a total amount not to exceed \$171,614 from the UASI grant program.
