1. Introductions

Curtis Jones called the meeting to order at 2:05 p.m.

2. Approval of Minutes from Previous Meeting – August 9, 2017

The minutes were approved as proposed.

3. Louisiana Calm Streets

John Kohler provided background on how the effort to promote Calm Streets (also known as neighborhood greenways, bike boulevards, neighborways) started in St. Louis. A one-mile Pilot Route along Louisiana Avenue was developed and funding was awarded through the Transportation Alternatives Program (TAP). The route was selected based on public engagement, low traffic volumes, connectivity and access to community resources, as well as being located in a PIER Neighborhood (Prevention, Intervention, Enforcement, Retention). Design elements incorporated into the project include bumpouts, traffic circles, speed humps, stop sign removal, and decorative crosswalks. There are ongoing efforts to expand the Calm Streets network, including a North City Pilot Route.

4. Downtown Multimodal Study

Jacque Lumsden presented an update on the Downtown Multimodal Study. The study is one component of a three-part project funded by the Congestion Mitigation and Air Quality (CMAQ) program, and was necessary after a few major projects, such as the new Mississippi River Bridge and the CityArchRiver project, impacted the downtown grid. The project kicked off in February, the second round of public engagement just concluded, and the final report is expected in March 2018. Engagement weeks have enabled study participants to further refine goals, objectives, and strategies. Four maps, based on mode, were drafted and introduced at the September engagement week:

bicycle, pedestrian, transit, and vehicle. The next step is to marry the mode maps with the identified strategies. Further details are now available online: www.downtownstltransportationstudy.com

5. **Chouteau Greenway Design Competition**

Mark Vogl provided an overview of the Chouteau Greenway Design Competition currently underway. It is a truly global competition, modeled after the CityArchRiver design competition, with private and non-profit partners funding the competition and engaged in the process. The goal is to create a vibrant corridor that will connect the Arch grounds and riverfront to Forest Park, as well as other greenways and destinations throughout the central corridor. Similar projects include the Beltline in Atlanta, the Sugar Creek Greenway in Charlotte, and the Cultural Trail in Indianapolis. The first segment of the Chouteau Greenway is already underway at Cortex and will be integrated with the new MetroLink station, which is set to be an iconic station. The competition launched a few weeks ago, will be narrowed down to four teams after the November 21 deadline, with final selection in April 2018, and design finalized in late June or early July. There are four committees planned in conjunction with the competition, and a voting jury with eight members and one alternate. <https://greatriversgreenway.org/Chouteau/>

6. **Delmar & I-170 Intersection Safety Improvements**

Angelica Gutierrez shared the proposed improvements to the Centennial Greenway crossing at the intersection of Delmar Blvd and McKnight Road. Improvements include pedestrian/bike signals, green painted crossings with refuge areas, trail signage, removal of a third westbound lane on Delmar, and a curb-separated cycle track along a portion of the east side of McKnight Road. The improvements were developed in response to user concerns and to reduce multiple conflict points. Tentative schedule includes public engagement in Fall 2017, final plans to be completed Spring 2018, and construction in Summer 2018.

7. **East-West Gateway Walking & Bicycling Survey**

Melissa Theiss presented the preliminary results of East-West Gateway's recent Bicycling & Walking Survey. The survey was open from May through October and a total of 671 completed surveys were received. The data revealed why people bike and walk, the desired types of facilities/improvements, bicyclists' skill levels, and perceived obstacles to biking and walking in the region. Further analysis is underway and will be shared when available.

8. **Trailnet's Protected Bikeways Vision**

Grace Kyung provided an update on Trailnet's vision for a network of protected bikeways in the region, including a map of potential, prioritized routes. Connections to parks, neighborhoods, and businesses came out as the top priority in Trailnet's public survey. Yesterday, all committees came together for the October Blender to share the work they have done so far. Some of the issues that were looked at include the vision's potential impact on neighborhoods, zoning, design, equity, and possible funding mechanisms. After November 2, Trailnet will host open houses and begin a more targeted public engagement process. <http://trailnet.org/work/community/>

9. **St. Louis County Project Updates**

John Hicks provided updates on three of St. Louis County's recent bicycle and pedestrian projects. 1) St. Louis County will be submitting a TIGER grant application for the West Florissant Great Streets project that began in 2012. The project is currently in the preliminary design stage, and will take into account transit and multimodal improvements. 2) The County anticipates the RFQ for their recently awarded Bike/Walk Plan to be released in December, with a robust public and stakeholder engagement process to follow. 3) A lane reconfiguration is planned for North & South Road, from Olive Blvd to Delmar Blvd.

1. **Introductions**

Curtis Jones called the meeting to order at 2:05 p.m.

2. **Approval of Minutes from Previous Meeting - - May 10, 2017**

The minutes were approved as proposed.

3. **Great Streets Initiative – Forest Park and Kimmswick**

Paul Hubbman presented an overview of the current Great Streets projects in Forest Park and Kimmswick, MO. The Forest Park project seeks to address four primary accessibility issues:

- 1) diffusing vehicular traffic congestion into and out of the park
- 2) mobility within the park and internal circulation
- 3) lack of supporting uses
- 4) neighborhood and pedestrian access to the park

The final plan is expected to be complete by December 2017.

The Kimmswick project was selected through a competitive process and will be addressing a series of unique, integrated issues such as connecting the downtown area to the riverfront, minimizing the impact of flooding, and accommodating tourism in a community of 158 people that can swell to 150,000 during festival season. The project is now selecting consultants, with expected completion in June 2018.

There will also be a project solicitation in Illinois this year, which will conclude in June 2018 with EWG producing a final plan for the selected community.

4. **Transportation Alternatives Program (TAP)**

Rachael Pawlak presented the projects recommended during the most recent solicitation for TAP funding. Project applications went online April 4 and were due to EWG on June 19. In Missouri, 33

applications requesting approximately \$18 million in federal funds were received. In Illinois, 15 applications requesting approximately \$3.8 million were received. Projects were evaluated by EWG staff, based on the criteria outlined in the long-range transportation plan. At their August 2nd meeting, the Transportation Planning Committee (TPC) recommended 15 projects for funding in Missouri, totaling \$9.1 million in federal funds, and six projects in Illinois, totaling \$1.4 million in federal funds. The public comment period is open August 3 through September 5. Recommended projects will be presented to the Board of Directors at its September 27 meeting for final approval and inclusion into the TIP. An updated map of TAP projects, including the recommended 2017 TAP projects was presented.

5. **Trailnet's Protected Bikeways Vision**

Grace Kyung provided information on Trailnet's new vision, which consists of a network of on-street protected bicycle facilities and sidewalks. Earlier today, Trailnet hosted its first blender, which brought together all of the five committees and 58 partner agencies to provide updates on progress and share feedback. The committees include:

- a) Destinations + Routes
- b) Land Use
- c) Funding + Governance
- d) Design + Placemaking
- e) Public Input

6. **St. Louis County Pop-up Traffic Calming Demonstration**

John Hicks presented information on the pop-up street design demonstration that was held on Saturday, July 15 from 10 a.m. to 2 p.m. on West Florissant Avenue. St. Louis County departments of Planning, Health, and Transportation partnered with Trailnet to demonstrate possible street and sidewalk improvements, including a temporary crosswalk, signage, and separated median and shoulder. The demonstration was unique in that it took place on a high-volume, five-lane arterial road, instead of a smaller, neighborhood street.

Curtis Jones called the meeting to order at 2:03 p.m.
- 2. Approval of Minutes from Previous Meeting** - - September 8, 2016
The minutes were approved as proposed.
- 3. Surface Transportation Block Grant Program – Suballocated and Congestion Mitigation and Air Quality Improvement Program**
Jason Lange updated the Committee on the STP-S and CMAQ application process. The applications are currently available on the EWG website and are due March 2, 2017. The funds can be used for bicycle and pedestrian improvements as standalone projects or as part of another transportation project. Applications will be reviewed and evaluated by EWG staff, and presented to the Transportation Planning Committee (TPC) at its May meeting. After the TPC makes its funding recommendation, the projects will go out for public comment in June and then presented to the Board of Directors at its August meeting for final approval.
- 4. Transportation Alternatives Program (TAP)**
Rachael Pawlak announced the upcoming TAP solicitation. The project workbook and application will be available on April 4, 2017 and due June 19, 2017. Project development workshops will be held in April for Missouri and Illinois project sponsors. There is approximately \$1.4 million available to program in the Illinois portion of the region, and approximately \$8.5 million available to program in the Missouri portion. 5. **Bicycle and Pedestrian Reasonable Progress**

Melissa Theiss presented a reasonable progress report on bicycle and pedestrian projects in the Transportation Improvement Program. The report identified projects that have federal funds programmed FY2017, and which projects are on schedule or delayed.

6. **Trailnet's New Vision and Planning Process**

Taylor March provided information on Trailnet's new vision, which consists of a network of on-street protected bicycle facilities and sidewalks. Trailnet will be organizing committees to help develop the Plan. The committees include:

- a) Routes and destination
- b) Land use policies
- c) Funding and governance
- d) Design and placemaking
- e) Public Input

7. **National Bicycle and Pedestrian Documentation Project**

Taylor March presented findings from the September 2016 bicycle and pedestrian counts. He presented a flyer with information on the results. Over the span of two days, 122 volunteers counted 13,005 people. The largest increase of bicyclists from 2015 to 2016 was at the Oakland and Tamm location, with a 130% increase. Forest Park Parkway and Euclid had the highest activity out of all of the other count locations, with 1,872 individuals counted bicycling or walking.

8. **Chair, Vice-Chair, and Transportation Planning Committee Representative**

The Committee nominated Curtis Jones, IDOT to serve as the BPAC Chair, and Grace Kyung, Trailnet, to serve as BPAC Vice-Chair. The Transportation Planning Committee (TPC) representative is Grace Kyung.

9. **Other Business**

The City of St. Louis will be submitting an application for the Bicycle Friendly Community designation. The application is due during the 1st week of February.

The City of St. Louis will begin working on a Downtown Multimodal Study in February 2017. The purpose of the Downtown Multimodal Study is to develop a transportation system where bicyclists and pedestrians feel safe. In addition, traffic counts will be collected and infrastructure will be inventoried to develop signal timing plans.

1. **Introductions**

Curtis Jones called the meeting to order at 2:00 p.m.

2. **Approval of Minutes from Previous Meeting** - - May 11, 2016

The minutes were approved as proposed.

3. **Great Streets Initiative Update**

Paul Hubbman gave a presentation on East-West Gateway's Great Streets Initiative. Paul explained that EWG took a different approach with the Great Streets Initiative than previous years. East-West Gateway staff acted as the primary consultant. Instead of hiring a consultant lead, East-West Gateway hired individual consultants to cover four disciplines: Urban Design/Planning, Transportation, Market, and Environment. The 2016 projects included:

- Gravois Road, Affton, MO
- Woodson Road, Overland, MO
- Main Street, Smithton, IL
- Dr. Martin Luther King Jr. Drive, St. Louis, MO
- North 14th Street, St. Louis, MO

Each project involved a four day charrette and a final report. Paul provided information to the BPAC on two projects: Gravois Road and Main Street in Smithton.

Gravois Road (River des Peres to Mackenzie Road): Paul explained that Gravois was an arterial that was expanded for more capacity and then Interstate 55 was constructed parallel to Gravois Road. Therefore, the car volumes decreased on Gravois Road. Gravois Road was built out in a way that hindered walking, biking, and storefront small business shop activity. This area is also the oldest

zip code demographically in the state of Missouri. Paul discussed the bike and pedestrian recommendations in the report, which focused on connections to River des Peres Trail and Grant's Trail. Not all of the recommended facilities are on Gravois Road. There are some areas on Gravois Road that will be high-stress for bicycling. Paul explained that there is subsequent work that needs to be done. St. Louis County will undertake a traffic study to determine if a road diet can be implemented. MoDOT will be resurfacing the road next summer. Paul explained that crossing the existing five lanes is difficult for pedestrians. As the traffic is calmed, it will become more practical to provide more street crossings. Main Street in Smithton: Main Street is a two-lane rural state road. Smithton is a growing community, as the population has doubled. Smithton has a struggling downtown, with new commercial developments occurring on the edge of town. In recent years, Smithton went through a complete streets exercise, looking at how to better connect their community to the existing assets with enhanced bicycle and pedestrian facilities. Paul explained that not all Great Streets projects are road diets. Adding a lane was a recommendation to alleviate some access management issues. Another recommendation was to reinforce and strengthen the pedestrian crossing points. John Kohler stated that the City of St. Louis has been working with MoDOT on the Gravois corridor from River des Peres to Downtown St. Louis to make lane modifications and closing some of the small triangular sections to make it safer for pedestrians. John asked if street closures were part of this Gravois Road Great Streets project. Paul stated that there were a couple of “stub streets” that physically end that were recommended for closure. Paul did note that he recommended working with the community and getting their input on any street closures.

4. **Surface Transportation Program – Suballocated (STP-S) Project Selection Criteria**

Jason Lange and Peter Koeppel presented a brief background on transportation legislation (i.e., Moving Ahead for Progress in the 21st Century and the Fixing America's Surface Transportation Act) and performance-based planning. Metropolitan Planning Organizations are accountable for setting targets and staying consistent with the long-range transportation plan. East-West Gateway is currently updating the Surface Transportation Block Grant (STBG) application and scoring criteria. The criteria is being updated to coordinate with the national goals of the current transportation legislation and the guiding principles of the long-range transportation plan. East-West Gateway is asking for comments on the criteria by October 1, 2016.

Peter Koeppel stated that East-West Gateway is proposing six application types: Road/Bridge Infrastructure, Transit, Congestion, Safety, Alternative Transportation, and Freight and Economic Development. The criteria was developed using federal and state guidance, best practices, and research on what other MPOs across the country were doing. East-West Gateway also established focus groups to help develop the application criteria. Since STBG is a flexible pot of money, Peter noted that it is important to make sure that different types of projects are competing against each other, so set-asides and silo funding will not be used. Peter also discussed the cost/usage calculations, which is still under development. The evaluation criteria was handed out to BPAC members for review and comment.

Peter explained that for the next funding round, East-West Gateway will be using the criteria from the 'old' selection process, however, East-West Gateway will be asking for additional information in the application and beta-test the new scoring criteria.

- 1. Introductions**
John Kohler called the meeting to order at 2:03 p.m.
- 2. Approval of Minutes from Previous Meeting** - - January 11, 2017
The minutes were approved as proposed.
- 3. Surface Transportation Block Grant Program – Suballocated and Congestion Mitigation and Air Quality Improvement Program**
Jason Lange updated the Committee on the STP-S and CMAQ application process. The applications were due March 2, 2017. The funds can be used for bicycle and pedestrian improvements as standalone projects or as part of another transportation project. Jason presented the Missouri projects that were recommended by the Missouri Transportation Planning Committee (TPC) on May 3, 2017. The Missouri TPC recommended funding 16 CMAQ projects (\$22.1 million federal) and 45 STP-S projects (\$37.4 million federal). The Illinois TPC will make its funding recommendations at their meeting on May 11. After the TPCs makes their funding recommendation, the projects will go out for public comment in June and then be presented to the Board of Directors at its August meeting for final approval.

Rachael Pawlak presented a map showing the recommended STP-S projects that incorporate bicycle facilities.
- 4. Transportation Alternatives Program (TAP)**
Rachael Pawlak stated that the TAP project workbook and application were available on April 4, 2017, and project applications are due to EWG on June 19, 2017. There is approximately \$1.4 million

available to program in the Illinois portion of the region, and approximately \$8.5 million available to program in the Missouri portion. TAP evaluations will be presented to the Missouri and Illinois TPCs for recommendation in August 2017. After the TPCs make their funding recommendation, the projects will go out for public comment (Aug 3 – Sept 5), and then will be presented to the Board of Directors at its September meeting for final approval and inclusion into the TIP.

5. **Bicycle and Pedestrian User Preference Survey**

Rachael Pawlak announced that EWG is currently administering a survey to understand bicycle and pedestrian preference in the St. Louis region. The survey is available at: <https://www.surveymonkey.com/r/walk-bike>. EWG plans to close the survey in summer 2017. Rachael asked the committee to help share the survey. Results will be shared with the Committee.

6. **Trailnet's New Vision and Planning Process**

Taylor March provided an update on Trailnet's new vision, which consists of a network of on-street protected bicycle facilities and sidewalks. Trailnet has developed five committees to help develop the Plan. The committees include:

- a) Routes and destination
- b) Land use policies
- c) Funding and governance
- d) Design and placemaking
- e) Public Input

A committee blender will take place on August 9 to bring together all five committees.

7. **Downtown Multi-Modal Study**

Jacque Lumsden provided an overview of the Downtown Multi-Modal Study. The Study is funded by CMAQ, and is one component of three. The two other components include: funding to staff the traffic management center and retiming of traffic signals. The Study will focus on increasing low-stress bicycle facilities, pedestrian enhancements, and transit usage. Traffic counts will be collected and infrastructure will be inventoried. Multiple stakeholder engagement sessions were held in April 2017. Topics included: Trailnet's vision project, bike/pedestrian, ADA, public transportation, etc. The study will conclude in 2018.

8. **Other Business**

John Kohler announced that the City of St. Louis received the Silver Bicycle Friendly Community designation.

9. **Events/Announcements**

Members of the Committee announced events for Bike to Work week. St. Louis County announced that they will have a refueling station on Bike to Work Day. Trailnet has several refueling stations in St. Louis City and St. Louis County.

The NACTO Sister Cities Bikeways Roadshow will be held in St. Louis June 8&9. Registration is open.
