CALL TO ORDER

The Executive Advisory Committee was called to order by David Courtway, Chair.

APPROVAL OF MINUTES OF MAY 17, 2022 MEETING

Motion was made by Mr. Etling seconded by Ms. Streeter, to approve the minutes of the May 17, 2022 meeting. Motion carried, all voting aye.

DISCUSSION ITEMS

Draft FY 2023-2026 Transportation Improvement Program and Regional Air Quality Conformity Determination

Jason Lange, EWGCOG, provided the draft TIP and AQCD documents to the committee for review and gave a brief overview of both documents and what they entail. Mr. Lange mentioned that the documents are updated annually and that staff works with project sponsors, funding agencies, and advisory committees to development recommended programs and projects. He then gave brief highlights and summaries of total programs for MoDOT (noting that IDOT programs have not yet been released by the Governor and will be added at a later date), Transit, Local Programs, Major Projects, Fiscal Constraints, and Air Quality Conformity Analysis (noting that the analysis is complete). Mr. Lange briefly pointed out the Public Participation noting public comment segment occurring July 1st through August 4th as well as the schedule for the upcoming five open houses occurring July 12th through July 27th; all information and results will be available on the EWGCOG website.

St. Louis Lambert International Airport Layout Plan Update and Master Plan

Rhonda Hamm-Niebruegge, St. Louis Lambert Airport, provided a presentation detailing layout plans for the future of the airport as well as the master plan. She gave an in-depth report of the planning process beginning with an overall background of the airport's initial development, current status, and the future of the airport. She pointed out that the master plan has been in the development stages for approximately two years; the draft will be presented to the FAA in June with final presentation in September. Ms. Hamm-Niebrugge noted that public input from stakeholders as well as the community has been gathered via surveys and open houses, and have been very well attended and beneficial in assessing and forecasting challenges and solutions. Ms. Hamm-Niebruegge continued discussing current industry conditions pointing out challenges and concerns and the increased need for Security Checkpoints since 9-1-1, as well as terminal needs in order to keep up with expected growth of passengers. She also noted and discussed alternative evaluations, growth of airport accommodations, preferred terminal plan (including a unified terminal and passenger access), funding sources, and next steps (implementing the program and construction).

ACTION ITEMS

Extension of September 30, 2022 Suspense Date for Locally Sponsored Projects

Brad Williams, EWGCOG, provided the committee requests for the one time schedule change allowed by the Policy on Reasonable Progress noting that the change allows sponsors to request a one-time extension (no later than June 1st), authorizes staff to grant extensions up to three months, and Board action on extension requests of three to nine months. Mr. Williams noted that as the June 1st deadline, staff received 34 eligible requests pointing out that one was for a three-month extension with the remaining 33 for a nine-month request. He pointed out that extensions are considered if sponsors can demonstrate that delays are beyond their control, federal funds have already been obligated on the project, or there is a realistic strategy in place to obligate all funds within the extended time.

Staff recommends that the 33 eligible projects be granted a one-year extension due to sponsors experiencing delays resulting from the COVID pandemic that created negotiation slowdowns and staffing issues resulting from the prior winter; federal funds for these projects must be obligated no later than September 30, 2023.

Motion approving the recommendation was made by Mr. Etling seconded by Mr. Doucleff. Motion carried, all voting aye.

Modifications to the FY 2022-2025 Transportation Improvement Program (TIP), Connected 2045, and the Related Air Quality Conformity Determination – Requested by Illinois and Missouri Sponsors

Brad Williams, EWGCOG, provided the committee with requests from the Illinois Department of Transportation (IDOT) to amend the TIP by adding eight new projects and modifying one project. The project summary is as follows:

Samantha Peterson, EWGCOG, presented to the committee the request authorizing expenditures of funds in support of regional security that will improve the region's disaster preparedness and response capabilities to purchase the following: seven mobile phone devices, 13 hotspot devices, and 24 months of service for the St. Louis Fusion Center from AT&T Mobility FirstNET; 24 months of services for the six FirstNET mobile devices utilized by STARRS Staff from AT&T Mobility FirstNET; and 138 tactical headsets for the regional tactical teams including Jefferson County Sheriff's Department, and the Police Departments for St. Charles County, St. Louis County and St. Louis City from Visions of Video for a total not to exceed \$181,750 from the UASI grant program and \$7,200 from STARRS Hospital Donation funds.

Motion approving the recommendation was made by Mr. Etling seconded by Mr. Doucleff. Motion carried, all voting aye.

OTHER BUSINESS

Jim Wild informed the committee that this would be the last meeting attended by Wesley Stephens, who will be retiring from MoDOT at the end of month. The committee thanked Mr. Stephens for his service and wished him well.

Subject: Auditors' Report on Financial Statements for Calendar Year 2021

Date: August 16, 2022

Keber, Eck & Braeckel (KEB) has completed the Council's annual audit for calendar year 2021. The audit examined both the Council's financial statements and compliance with the requirements described in the OMB Compliance Supplement for each of the Council's major federal programs. The audit was conducted in accordance with generally accepted auditing standards, government auditing standards issued by the Comptroller General of the United States, and the audit requirements of Title 2 U.S. Code of Federal Regulations Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (Uniform Guidance).

We want to make you aware of new language in the auditor's governance letter this year. For this year, new audit standards (Statement on Auditing Standards 134-140) went into effect that require additional communication with the Board of Directors about significant risks identified during planning for the audit engagement. The intent of these standards is to provide additional transparency in the audit process. To comply with these new standards, KEB's governance letter identifies these risks. The risks identified by KEB do not mean that they believe that EWG management has taken actions or has deficient processes that created these risks; these risks are presumed to be default significant risks in every audit engagement regardless of an entity's actual control environment. As auditors, KEB is required to design their audit procedures to respond to the identified risks. This is not a new process; this is a process KEB uses every year for EWG's audit. The only difference is that KEB is now required to communicate with the Board of Directors about the identified risks. Importantly, if KEB identified any issues with EWG's internal controls, it would communicate those to the Board of Directors in the Report on Internal Control.

KEB's audit did not identify any material weaknesses or significant deficiencies in the Council's internal control over financial reporting and did not note any noncompliance material to the financial statements as presented. KEB's audit also did not identify any material weaknesses or significant deficiencies in the Council's internal control cover its major programs and did not identify any federal award findings or questioned costs. KEB issued an unmodified opinion with respect to both the Council's financial statements and the Council's compliance with its major programs. A summary of

Louis Region

Date: August 16, 2022

East-West Gateway Council of Governments plans to submit a Safe Streets and Roads for All (SS4A) discretionary grant program application to develop a comprehensive safety action plan for the St. Louis region. The SS4A program is funded through the US Department of Transportation (USDOT) and the application deadline is September 15, 2022. The SS4A grant program is a discretionary program that supports planning, infrastructure, behavioral, and operational initiatives to prevent death and serious injury on roads and streets involving all roadway users.

The purpose of the SS4A program is to improve roadway safety by significantly reducing or eliminating roadway fatalities and serious injuries through action plan development and implementation focused on all users, including pedestrians, bicyclists, public transportation users, motorists, micromobility users, and commercial vehicle operators. The SS4A program provides funding for two main types of grants: Action Plan Grants and Implementation Grants. Action Plan Grants are used to develop, complete, or supplement a comprehensive safety action plan. To apply for an Implementation Grant, an eligible applicant must have a qualifying action plan in place. Implementation Grants are available to implement strategies or projects that are consistent with an existing action plan. If the Council is awarded this grant and develops the comprehensive safety action plan, counties and municipalities in the region can elect to adopt the plan, which will enable them to apply for implementation grants that support the strategies and projects identified in the plan.

The USDOT will award Action Plan Grants based on the safety impacts, equity investments, and other safety considerations such as employing systemic safety improvements over a wider geographical area. In addition, action plans must include the following components:

- An official public commitment to an eventual goal of zero roadway fatalities and serious injuries.
- A task force charged with oversight of action plan development.

- A set of comprehensive projects or strategies that will address the safety problems.
- A method to measure progress over time after the action plan is developed.

The availability of funds to develop a comprehensive safety action plan has come at a critical time for the St. Louis region. On average, 300 lives are lost per year on St. Louis roadways. Unfortunately, the trend is not moving in the right direction towards zero deaths. A comprehensive safety action plan will allow the region to center efforts around the people most impacted by traffic crashes and will position counties and municipalities in the region to leverage SS4A grants to help reduce traffic fatalities and serious injuries.

Staff Recommendation: Staff recommends that the Board of Directors adopt the resolution supporting the development of a comprehensive safety action plan for the St. Louis region.

- 1. The East-West Gateway Council of Governments Board of Directors supports the Council's effort to develop a comprehensive safety action plan for the St. Louis region.

Appendix A of the Transportation Improvement Program (TIP) document contains the Metropolitan Transportation Planning Process certification. This certifies that East-West Gateway Council of Governments (the Council) meets the requirements of 23 CFR §450.336 and must be signed by the Council, Missouri Department of Transportation (MoDOT), and Illinois Department of Transportation (IDOT). It must also be approved by the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA). The certification is part of the TIP document. The certification language may be found in **Attachment A** of this memo.

Air Quality Conformity Analysis

Since the St. Louis region is designated as a non-attainment area for air quality, the TIP must be analyzed to determine its conformity with air quality plans and objectives. Staff completed this analysis prior to the draft TIP being released for public comment in June. Subsequent TIP modifications were determined to have no impact on the conformity finding. The projects in the proposed transportation program meet the applicable air quality conformity requirements.

FY 2023-2026 Transportation Improvement Program

Each year the Board of Directors adopts a TIP that allocates federal funds to transportation projects. The program comprises the first four years of projects and strategies in the regional long-range transportation plan. Before a project is eligible to receive federal funds it must be included in the TIP.

The FY 2023-2026 TIP has been developed using priorities, procedures, and policies approved by the Board of Directors through the adoption of the long-range transportation plan, Connected 2045. Staff has worked with project sponsors, funding agencies, and advisory committees to develop the recommended program of projects.

Total Program Summary

The FY 2023-2026 TIP contains 842 new and previously programmed projects totaling nearly \$3.66 billion. The majority of these projects (636) are currently programmed in the FY 2022-2025 TIP and presented for reprogramming with some adjustments. All of the projects proposed by sponsors to retain their program status are recommended for reprogramming.

The FY 2023-2026 TIP differs from the draft TIP that was submitted for public comment. Sixty-six projects have been added and two projects were removed, which yields a net increase of 64 projects. A majority of the projects added to the TIP are carryover projects from the FY 2022-2025 TIP including local projects that received a one-time schedule extension in June. These changes are reflected in the table below by program and detailed in **Attachment B**.

IDOT Program Summary

IDOT's program contains 21 reprogrammed or rescheduled projects at a total cost of \$99.5 million. The 21 projects included in the FY 2023-2026 TIP were included in the FY 2022-2025 TIP and are scheduled for letting through March 2023 in FY 2023. The Governor of Illinois released the IDOT program on August 12. The remainder of the IDOT program will be amended to the FY 2023-2026 TIP at a later date following a public comment period.

<u>MoDOT Program Summary</u>

MoDOT's program contains 258 projects at a total cost of \$1.9 billion. This includes 174 reprogrammed or rescheduled projects and 84 new projects.

Fifty-three percent of MoDOT's program is for preserving the existing infrastructure and 18 percent is for capacity adding projects. Seventeen percent of the program is for operational and safety needs. Another 11 percent of MoDOT's total program is allocated for projects such as studies or payback projects, including GARVEE bonds for the

Mississippi River Bridge, Safe and Sound, and the I-64 reconstruction. The remainder (one percent) includes work specifically related to pedestrian improvements.

Transit Program Summary

In Missouri and Illinois, 184 transit projects (151 reprogrammed and 33 new) were submitted for programming. The total cost of the transit projects is \$895.3 million.

Bi-State Development/Metro's program consists of 80 projects at a total cost of \$855.6 million, while the program submitted by the Madison County Transit District contains 29 projects at a total cost of \$28.6 million. Most of the funding in Metro's and Madison County Transit District's programs comes from FTA Section 5307 funds.

The other 75 projects in the transit program (\$11.1 million) consist of Section 5310 (Enhanced Mobility of Seniors and Individuals with Disabilities) projects.

Summary of Local Programs

The local Illinois program contains 115 projects (87 reprogrammed and 28 new) at a total cost of \$154.5 million. The 28 new projects have a total cost of \$27.7 million (\$20.6 million in federal funds).

The local Missouri program contains 264 projects at a total cost of \$611.6 million. Included are 203 reprogrammed projects and 61 new projects. The 61 new projects have a total cost of \$195.3 million (\$130.8 million in federal funds).

Financial Capacity

The TIP is required to be fiscally constrained, with reasonable assurance that funds will be available to implement the proposed projects in a given year. Staff has evaluated the federal funds programmed in the TIP with regard to amounts authorized in federal legislation and anticipated federal spending limitations. The proposed federal funding levels for the entire program do not exceed the funds anticipated to be available in the various program years.

The state DOTs, transit agencies, and local sponsors have incorporated inflation factors into the cost estimates for their projects that are expected to be implemented beyond the first year of this TIP. Further, each of the local implementing agencies has submitted written certification indicating that non-federal matching funds are available for their respective projects. In this way, there is some assurance that proposed projects represent true commitments on the part of local agencies rather than project "wish lists."

Public Participation

The draft TIP and Air Quality Conformity Determination were circulated for public comment from July 1 through August 4. Information on the comment period was posted on the Council's website, in the Council's *Local Government Briefings* newsletter, on the Council's Facebook and Twitter page, and advertised in local newspapers. Council staff was available to answer questions about the documents. Comments could be made through the Council's webpage, email or mail. Overall, 53 people attended the public open house meetings. A total of 20 comments were received through the online comment form, open house public comment form, email, and mail.

A summary of the public comments received is included in **Attachment C.** Also, staff has assembled a separate *Summary of Public Comments* document that contains all of the comments received during the public comment period. Staff does not recommend any changes to these documents based on these comments.

METROPOLITAN TRANSPORTATION PLANNING PROCESS CERTIFICATION

In accordance with 23 CFR § 450.336, the Illinois Department of Transportation, the Missouri Department of Transportation, and the East-West Gateway Council of Governments (EWGCOG), the Metropolitan Planning Organization for the St. Louis urbanized area, "certifies" that the transportation planning process is addressing the major issues in the metropolitan planning area and is being conducted in accordance with all applicable requirements of:

- 1. 23 U.S.C. § 134, 49 U.S.C. § 5303, and 23 CFR Part 450 Subpart C;
- 2. Sections 174 and 176(c) and (d) of the Clean Air Act, as amended (42 U.S.C. §§ 7504, 7506(c) and (d)) and 40 CFR Part 93;
- 3. Title VI of the Civil Rights Act of 1964, as amended (42 U.S.C. § 2000d et seq.) and 49 CFR Part 21;
- 4. 49 U.S.C. § 5332 prohibiting discrimination on the basis of race, color, religion, national origin, sex, disability, or age in employment or business opportunity;
- 5. Section 1101(b) of the Fixing America's Surface Transportation (FAST) Act (Pub. L. No. 114-357) and 49 CFR Part 26 regarding the involvement of disadvantaged business enterprises in U.S. DOT funded projects;
- 6. 23 CFR Part 230, regarding the implementation of an equal employment opportunity program on federal and federal-aid highway construction contracts;
- 7. The provisions of the Americans with Disabilities Act of 1990 (42 U.S.C. § 12101 *et seq.*) and 49 CFR Parts 27, 37, and 38;
- 8. The Older Americans Act, as amended (42 U.S.C. § 6101 *et seq.*) prohibiting discrimination on the basis of age in programs or activities receiving federal financial assistance;
- 9. Section 324 of the Title 23 U.S.C. regarding the prohibition of discrimination based on gender; and
- 10. Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. § 794 *et seq.*) and 49 CFR Part 27 regarding discrimination against individuals with disabilities.

EWGCOG is exempt from the requirements of 23 U.S.C § 134(d)(2) and 49 U.S.C. § 5303(d)(2), as amended by the FAST Act §§ 1201 and 3003 because: (1) EWGCOG operates pursuant to the Missouri State and Regional Planning and Community Development Act (Mo. Rev. Stat. Chapter 251) and the Missouri Nonprofit Corporation Act (Mo. Rev. Stat. Chapter 355), which were both in effect on or before December 18, 1991; (2) these Missouri laws have not been amended after December 18, 1991, as regards EWGCOG's structure or organization; and (3) EWGCOG has not been designated or re-designated after December 18, 1991.

Staff is requesting authorization to expend funds in support of regional security that will improve the region's disaster preparedness and response capabilities. Funding will come from the U.S. Department of Homeland Security's Urban Area Security Initiative (UASI) grant program. Attachment A summarizes the purchases, totaling \$232,350.00.

ST. LOUIS FUSION CENTER:

Kaseware: Staff is seeking approval to renew the Kaseware case management, team management and document management system software licenses for use by Fusion Center Investigators and Analysts. The Kaseware renewal, which includes 15 full user licenses and seven (7) SocialNet licenses, will allow Fusion Center personnel to work with peer agencies and contribute to the exchange of investigative information and material in support of counterterrorism efforts. The total cost for the 12-month renewal will not exceed \$22,550 from the UASI FY 2019 and FY 2021 grants.

REGIONAL CYBERSECURITY INITIATIVE:

Recorded Future Renewal – Staff is seeking the 12-month renewal of four (4) software licenses for the Recorded Future cybersecurity intelligence software for use by the Regional Cybersecurity Coordinator and Analyst, as well as other investigators and analysts in support of the Regional Cybersecurity Initiative. The software provides cybersecurity related intelligence and analysis of a unique nature to include threat, brand, vulnerability and geopolitical intelligence. The total cost will not exceed \$119,800 from the UASI FY 2019 and FY 2021 grants.

DOMESTIC VIOLENT EXTREMISM:

CobWebs Renewal - Staff is seeking the renewal of the Cobwebs online threat identification, social media analyst, and alerting tool for use by the Regional Cybersecurity Coordinator and Analyst, as well as other investigators and analysts, in support of the Homeland Security Grant Program's Combating Domestic Violent Extremism priority area, which is a required priority area by the U.S. Department of Homeland Security / FEMA in the UASI 2021 grant. The Cobwebs platform allows the Fusion Center personnel to identify online threats and threat actors and contributes to the exchange of investigation information and capabilities with Fusion Center peers. Three software (3) licenses, in addition to dark web monitoring access, will be renewed for a 12-month period. The total cost will not exceed \$90,000 from the UASI FY 2019 and FY 2021 grants.
