CALL TO ORDER

The Executive Advisory Committee was called to order by David Courtway, Chair.

APPROVAL OF MINUTES OF SEPTEMBER 20, 2022 MEETING

Motion was made by Mr. Etling, seconded by Mr. Falls, to approve the minutes of the September 20, 2022 meeting. Motion carried, all voting aye.

ACTION ITEMS

Calendar Year 2023 East-West Gateway Budget

Jim Wild, EWGCOG, provided the committee with an overview of the yearly budget to be presented at the annual meeting for approval. Mr. Wild gave an overview of the budget discussing operating expenses as well as anticipated revenue to be received from federal, state, and local agencies. He noted that the 2023 proposed budget of \$13,640,860 includes funding for public safety, software & training, consulting services for transportation & environmental work, as well as Council's staff and operating costs projected at \$6.9 million. He also mentioned that the per capita contribution from each member county will remain at 12.5% and has been the same amount since 2005 and may need to be reviewed at a later time. Mr. Wild also noted that two additions have been made regarding Juneteenth as one of the observed holidays, and paid jury duty to both full-time and part-time employees. He added that a pay plan adjustment of 4.0% will be effective January 1, 2023 is being proposed.

Staff recommends approval of the 2023 budget at the annual meeting and adoption of the updated personnel plan including the pay grade plan adjustment.

Motion to recommend approval of staff's recommendation was made by Mr. Etling seconded by Mr. Doucleff. Motion carried, all voting aye.

Long Range Transportation Plan - Guiding Principles

Marcie Meystrik, EWGCOG, refreshed the committee of the proposed Guiding Principles presented previously noting that some minor tweaks have been made to two definitions of the principles based on staff's input. Ms. Meystrik pointed out that the definition for the Guiding Principle "A Healthy and Sustainable Environment" was modified to remove the reference to climate change and the definition for the Guiding Principle "Economic Vitality" was modified to increase the focus on freight. She thanked everyone for their comments and input.

Staff recommends the adoption of modifications to the guiding principles of the Connected 2050 long-range transportation plan.

Motion to recommend approval of staff's recommendation was made by Mr. Etling seconded by Mr. Larson. Motion carried, all voting aye.

Functional Classification Update

Brenden Giblin, EWGCOG, provided the committee with the recommendations based on revision applications submitted by county and municipal officials requesting function class changes. Mr. Giblin noted that applications were reviewed by staff along with representatives from both MoDOT and IDOT according to the FHWA guidelines.

Staff recommends the adoption of the 114 changes deemed consistent with the functional classification to be submitted for final approval by FHWA.

Motion to recommend approval of staff's recommendation was made by Mr. Falls seconded by Mr. Hampel. Motion carried, all voting aye.

Illinois Department of Transportation amendment to the FY 2023-2026 Transportation Improvement Program, *Connected2045*, and the Related Air Quality Conformity Determination

Jason Lange, EWGCOG, reminded the committee of the previously presented IDOT amendments mentioning that only 21 projects (scheduled through March 2023) were included in the FY 2023-2026 TIP and approved on August 31, 2022. Mr. Lange pointed out that IDOT is requesting to amend the remainder of its programs to the FY 2023-2026 TIP, adding a total of 68 projects whereby three more projects were included that slightly affects the cost. He gave a brief description of major programs, air quality conformity, and public participating noting that the public comment period was from September 16 through October 17 where no comments had been posted or received.

Staff recommends that the FY 2023-2026 TIP be revised to include the IDOT amendments.

Motion to recommend approval of staff's recommendation was made by Mr. Etling seconded by Mr. Doucleff. Motion carried, all voting aye.

Modifications to the FY 2023-2026 Transportation Improvement Program (TIP), *Connected2045*, and the Related Air Quality Conformity Determination – Requested by Illinois and Missouri Sponsors

Brad Williams, EWGCOG, provided the committee with requests from the Illinois Department of Transportation (IDOT) and the Missouri Department of Transportation (MoDOT) to amend the TIP by adding two new projects and modifying two projects. The project summary is as follows:

Jim Wild, EWGCOG, presented to the committee the request authorizing expenditures of funds in support of regional security that will improve the region's disaster preparedness and response capabilities for the following: purchase one thermal imaging digital moving map system; and, allow the Executive Director to enter into a contract with IEM to assist and support a regional planning, training, and exercise project for a total amount not to exceed \$737,520 from the UASI and RCP grant programs, respectively.

Staff recommends approval of the expenditure of funds as presented.

Motion to recommend the approval of staff's recommendation was made by Ms. Nelson seconded by Mr. Falls. Motion carried, all voting aye.

OTHER BUSINESS

Jim Wild reminded the committee of the upcoming Annual Meeting to be held in-person on Thursday, November 17, 2022 at the Hilton St. Louis at the Ballpark including a Morning Session and Awards Ceremony. He noted that the registration link as well as email invitations would be sent out to members.



Summary of Transportation Alternatives Program Project Recommendations

January 10, 2023

Board of Directors

East-West Gateway Council of Governments (EWG) announced a call for project applications for federal funding through the Transportation Alternatives Program (TAP) on June 1, 2022. TAP provides funding for on- and off-road pedestrian and bicycle facilities, community improvement and environmental mitigation activities, and safe routes to school projects. Project applications were due on August 19, 2022. EWG received 21 TAP applications in Illinois requesting approximately \$10.8 million in federal funds and 40 TAP applications in Missouri requesting approximately \$47.6 million in federal funds.

Staff has completed the evaluation of TAP project applications and the Illinois and Missouri Transportation Planning Committees (TPC) made funding recommendations at their January 2023 meetings. The Illinois TPC recommended eight projects at a cost of \$3.6 million in TAP funds. The Missouri TPC recommended 21 projects at a cost of \$21.6 million in TAP funds. Attachment A details the TPC recommendations by state.

Two projects recommended for TAP funding in Illinois have also applied for funding through the Illinois Transportation Enhancement Program (ITEP) statewide solicitation (ID #s 7285E-25 and 7285F-24). In the event that these projects are awarded ITEP funding, a contingency list of projects to be recommended for TAP funding is included below, in order of contingency priority.

Consultant Selection for Arterial Study

January 10, 2023

In 2006, the Council launched the Great Streets Initiative, encouraging communities to incorporate a wide range of issues and goals for their significant streets through planning assistance. Council staff, coordinating with MoDOT staff, identified a project to assess the arterial road network in the region and develop alternative design considerations based on urban context. This work will be conducted within the Great Streets Initiative program, consistent with the Council's Unified Planning Work Program.

To solicit consulting services for the study, the Council released a Request for Proposals (RFP) on September 30, 2022, with a closing date of November 1st. Five consulting teams responded to the RFP:

- Crawford, Murphy, & Tilly as the lead consultant with EFK Moen, SWT, and Development Strategies
- Stantec as the lead consultant with Lochmueller, Added Dimension, Public Design Bureau / Insight Design Kitchen, JS Lane Company, and Trailnet
- Toole Design as lead consultant with CBB Transportation, Trailnet, and Civil Design Incorporated
- WSP as lead consultant with EFK Moen, Lion CSG, and Excel Business Solutions

A selection committee representing MoDOT and the Council reviewed and scored the proposals. The teams led by Crawford Murphy & Tilly, Stantec, and WSP were interviewed on December 12. Subsequently, the selection committee recommended that the contract be awarded to the team led by WSP.

Regional Security Expenditures

January 10, 2023

Staff is requesting authorization to expend funds in support of regional security that will improve the region's disaster preparedness and response capabilities. Funding will come from the U.S. Department of Homeland Security's Urban Area Security Initiative (UASI) grant program. Attachment A summarizes the purchases, totaling \$1.049.900.

ST. LOUIS FUSION CENTER:

FirstNET Compact Rapid Deployable (CRD) Device – Staff is seeking approval to purchase a FirstNET CRD device for the St. Louis Regional Fusion Center and St. Louis County Police Department Office of Emergency Management. FirstNET is a federal government initiative providing a dedicated mobile voice/data network for first responders such as law enforcement, fire, EMS, and emergency management. The CRD is a small, deployable mobile tower that provides expanded connectivity to FirstNET phones and other devices during large-scale emergency response incidents, when communications are often disrupted. The CRD will stabilize communications environments, improve operable and interoperable communications capabilities for first responders, and is capable of working with communications satellites, helping to ensure that even in the worst possible scenario (where all local communications assets are disrupted) communications can still occur with those beyond the scene. This device can also be deployed at planned events to increase and help ensure available bandwidth for public-safety FirstNET mobile phones and devices. The total cost of the deployable CRD from Rescue 42 CRD in collaboration with AT&T Mobility FirstNET will not exceed \$83,250 from the UASI grant program.

Suspicious Activity Reporting / Intelligence Liaison Officer (SAR/ILO) Position - The SAR/ILO position within the St. Louis Regional Fusion Center addresses critical gaps in suspicious activity reporting and outreach capabilities, the need for a more complete regional intelligence platform and enhancement of communications between federal, state and local public safety agencies as well as private sector entities. The SAR/ILO is responsible for collection, analysis and dissemination of information obtained through suspicious activity reporting, increasing the Fusion

Center's outreach capabilities, and directly leading to the prevention of terrorist,

criminal, and domestic violent extremist activities on a multi-jurisdictional, multidisciplinary level. Staff is requesting approval to enter into a sub-award agreement with Jefferson County to provide funding to support the SAR/ILO position in the St. Louis Regional Fusion Center for the period of May 1, 2023 to July 31, 2024. The total cost for salary and benefits for the SAR/ILO position will not exceed \$140,000 from the UASI grant program.

Strategic Intelligence Analyst Position - This position is crucial to the function of the St. Louis Regional Fusion Center, which analyzes information and identifies trends to share timely law enforcement intelligence data with federal, state and local law enforcement entities. Duties of an Intelligence Analyst include, but are not limited to, researching tactics, techniques and procedures of domestic and international terrorist groups, developing Safety Alerts and Bulletins for St. Louis regional law enforcement agencies, answering daily requests for information from private sector, local, state and federal sources, interaction and research with other Fusion Centers around the country to develop timely and accurate intelligence products, analysis of received federal law enforcement data for determination of relevance for the St. Louis region, and interaction, analysis, and dissemination of cyber-crime threat information. Staff is requesting approval to enter into a sub-award agreement with the City of Chesterfield to provide funding to support a Strategic Intelligence Analyst position in the St. Louis Regional Fusion Center. The total cost for salary and benefits for the Intelligence Analyst position will not exceed \$150,000 for the period of April 1, 2023 through July 31, 2024 from the UASI grant program.

COMPLEX COORDINATED TERRORISM ATTACK (CCTA) PLANNING, TRAINING & EXERCISE

CCTA Investigation, Reunification and Recovery – Staff is seeking approval to hire a consultant that will develop a planning project focused on the St. Louis Regional Complex Coordinated Terrorist Attack program and the development of guidance documents pertaining to investigation, reunification, and recovery, building upon the work previously developed as part of the CCTA program. Key components of this phase in the Region's CCTA program will be engaging in planning meetings and scenario-based workshops to develop guides designed to integrate response partners who traditionally are engaged with a CCTA response after the active threat(s) have been resolved. The guides will have specific components that will guide community partners to successfully address coordinated witness management and investigation, family reunification, and coordinated family notification of fatalities within the scope of ongoing response and recovery needs from a complex attack. The total cost will not exceed \$334,900 from the UASI grant program.

CCTA Intelligence Liaison Officer (ILO) Program – The Region's CCTA program has expanded the ILO program within the St. Louis Regional Fusion Center, building a robust prevention, intervention, and response mindset to a CCTA type incident through planning, training, and exercise. It is the intent of the Region to expand and improve education materials used in the Fusion Center's ILO program. Key components of this phase in the Region's CCTA program will enhance the existing ILO program and support its rollout to the Region. The current ILO program within the Fusion Center interacts with over 1,000 contacts across various disciplines. The Region's initial CCTA program investments provided a CCTA ILO staff member who provided Fusion Center awareness training to first responders and other whole community partners. This project will build on past and current ILO program and national best practices. Staff is seeking approval to hire a consultant to assist with the planning, training and exercise project for an amount not to exceed \$67,300 from the UASI grant program.

REGIONAL TRAINING:

Urban Search and Rescue (US&R) Heavy Equipment Rigging Specialist

(HERS) Training – Staff is seeking approval to hire a consultant to deliver a Federal Emergency Management Agency (FEMA) equivalent HERS course to US&R task force personnel in the St. Louis Region. The course is a 32-hour, four (4) day course designed to provide US&R task force personnel with the knowledge, skills and abilities to perform HERS functions for a US&R team during a disaster or planned event. Personnel will learn successfully perform the position of HERS, encompassing structural collapse training for the assessment and mitigation of various types of collapses of structures / buildings, and learning advanced rigging and crane operations skills as well as heavy equipment applications. The total cost of the course will not exceed \$36,440 from the UASI grant program.

U.S. Fire Administration (USFA) O-305, Type 3 All Hazards Incident

Management Team (AHIMT) Training - The USFA O-305, Type 3 AHIMT Introduction course consists of 40 hours / five days of team-specific training designed to prepare its members to better service their local communities with the capabilities to manage large scale or complex emergency incidents by providing the knowledge, skills and abilities necessary to function within the framework of a Type 3 AHIMT deployed to an incident or planned event. Staff is seeking approval to hire a consultant to deliver the course to interdisciplinary emergency response personnel, including but not limited to fire, law enforcement, emergency medical services,

emergency management, public health, and mass care in the St. Louis Region. The total cost of the course will not exceed \$27,700 from the UASI grant program.

US&R Medical Team Specialist Training – Staff is seeking approval to hire a consultant to deliver a FEMA-equivalent US&R Medical Team Specialist course, which is a 59-hour, six (6) day course designed to provide US&R task force personnel with the knowledge, skills and abilities to perform medical functions for a US&R team during a disaster or planned event. Personnel will learn to navigate operational aspects and organizational issues that affect their ability to practice medicine. The US&R Medical Team Specialist is responsible for the general health considerations of and delivery of medical care to other task force personnel, victims and search canines, as well as the implementation of medical action plans under the direction of the Medical Team Manager. In addition, the Medical Team Specialist is responsible for the accountability, maintenance and repairs of the necessary equipment, and other duties as assigned during a disaster or planned event. The total cost of the course will not exceed \$83,410 from the UASI grant program.

US&R Initial Training Series – Staff is seeking approval to hire a consultant to deliver Initial Training Series courses for US&R task force personnel in the St. Louis Region. The Initial Training Series will provide personnel with the knowledge, skills and abilities to perform various functions for a US&R team during a disaster or planned event, and includes Technical Rescue Core, Rope Rescue Level I, Rope Rescue Level II, Confined Space Rescue Technician, Trench Rescue Operations and Technician, Structural Collapse Operations and Technician, Swiftwater Rescue Technician and Boat Operator Technician courses. The total cost for all courses will not exceed \$126,900 from the UASI grant program.

STAFF RECOMMENDATION:

Staff recommends that the Board approve the expenditure of funds as follows:

- for the purchase of one (1) FirstNET Compact Rapid Deployable device from Rescue 42 of Chico, CA, in collaboration with AT&T Mobility FirstNET of Carol Stream, IL in an amount not to exceed \$83,250;
- allow the Executive Director to enter into a sub-award agreement with Jefferson County, MO to support the Suspicious Activity Reporting / Intelligence Liaison Officer position for 14 months in an amount not to exceed \$140,000;

- allow the executive director to enter into a sub-award agreement with the City of Chesterfield, MO to support the Strategic Intelligence Officer position for 15 months in an amount not to exceed \$150,000;
- allow the Executive Director to enter into a contract with Hagerty Consulting, Inc., of Evanston, IL to assist and support a focused regional CCTA Investigation, Reunification and Recovery planning, training, and exercise in an amount not to exceed \$334,900;
- allow the Executive Director to enter into a contract with Hagerty Consulting, Inc., of Evanston, IL to assist and support a focused regional CCTA Intelligence Liaison Officer planning program in an amount not to exceed \$67,300;
- allow the Executive Director to enter into a contract with Spec International of Virginia Beach, VA to deliver a US&R Heavy Equipment Rigging Specialist training course to regional US&R teams in an amount not to exceed \$36,440;
- allow the Executive Director to enter into a contract with the University of Missouri Fire Rescue Training Institute of Columbia, MO to deliver a U.S. Fire Administration (USFA) O-305, Type 3 All Hazards Incident Management Team (AHIMT) training course to regional first responders in an amount not to exceed \$27,700;
- allow the Executive Director to enter into a contract with Disaster Medical Solutions of Cape Coral, FL to deliver a US&R Medical Team Specialist training course to regional US&R teams in an amount not to exceed \$83,410;
- allow the Executive Director to enter into a contract with Total Technical Rescue Solutions of Lake St. Louis, MO to deliver US&R Initial Series training courses to regional US&R teams in an amount not to exceed \$126,900;

for a total amount not to exceed \$1,049,900 from the UASI grant program.
