1. Introductions

Jacque Knight called the meeting to order at 2:02 p.m.

Approval of Minutes from Previous Meeting – November 9, 2022 The minutes were approved as proposed. John Kohler made the motion to approve and Kevin Jemison seconded the motion.

3. Committee Elections – Chair, Vice Chair, and TPC Representatives

Members voted to return to in-person meetings on May 10, 2023. Committee positions were nominated and elected as follows: Jacque Knight – Chair Sara Nelson – Vice Chair Angelica Gutierrez – TPC Representative (primary) Mark Vogl – TPC Representative (secondary)

4. MetroLink Secure Platform Plan

Kevin Scott presented an overview of Metro's Secure Platform Plan (SPP) and the current status of the project. Following a study conducted by WSP three years ago, Metro decided to move forward with the SPP as part of a comprehensive set of security measures. The SPP will reconfigure MetroLink from an open system to a gated system and all platforms will have a real-time security camera system

(CCTV). A new fare collection system is also part of the project and those improvements will extend to MetroBus as well. The project is currently in design and construction will be phased in order to get started sooner, demonstate progress to the public, and show what the new system will look like. Four stations in Illinois have been selected as pilot projects and are expected to be implemented in the beginning of 2024. Those locations will be staffed at first since the communication and fare system upgrades will come later. The project is estimated to cost about \$52 million and is funded by Bi-State, St. Louis County bonds, American Recovery funds, and about \$11 million in private funding.

5. Brickline Greenway

Mark Vogl updated the committee on the Brickline Greenway's progress and the three categories of projects being tracked – built, active (which are in various stages of design, planning, and even construction), and . When complete, the Brickline will connect four anchor institutions – Forest Park, Tower Grove Park, Fairgrounds Park, and the Gateway Arch National Park. Updates include:

- Market Street between 20th and 22nd is close to completion and will have a public ribbon cutting on February 19 from 2:00 to 4:00pm.
- Market Street west to Compton and Harris Stowe in under design.
- Cortex station to Grand received a \$4 million CMAQ grant to fund that extension, with construction in a couple of years.
- GRG is working with Washington University Medical Center to develop a scope of work for the segment/connection between Cortex and Forest Park.
- Grand Blvd from Fairground Park and Natural Bridge to Page Ave, and then Spring Ave from Page to SLU, has received funding from several grants, including a \$15 million RAISE grant.
- GRG has submitted an application for Reconnecting Communities funds to construct a greenway crossing I-64 and providing better north-south access and connectivity between the Foundry and the Armory.

6. Centennial Greenway

Angelica Gutierrez shared updates on the Centennial Greenway, which currently runs from Forest Park, through Washington University's campus, west through University City connecting major parks like Heman and Ruth Park, and then north along I-170. GRG is in the process of acquiring property in Olivette to continue west with the greenway, connecting to additional parks and eventually the 39North District. A partnership with St. Louis County to build out the greenway, adjacent to the roadway, along Shuetz Road west through Maryland Heights towards Creve Coeur. The master plan for the Centennial Greenway is being carried out in small segments and stages at different times to complete the overall project.

7. Safe Streets and Roads for All (SS4A)

Anna Musial announced that EWG has been awarded a SS4A grant to develop a region-wide comprehensive safety action plan by the USDOT. The majority of awards for this round were for action plans, with 473 planning grants and 37 implementation grants awarded across the country. Once the St. Louis region's plan is complete, any county or municipality that adopts the plan will be eligible to apply for funding through the SS4A program to implement strategies or projects identified in the plan. EWG anticipates executing agreements with USDOT this spring and will then be able to get to work developing the plan. Outcomes of the MODOT Arterial Safety Study that is now underway will be rolled into the action plan where applicable.

8. Transportation Alternatives Program (TAP)

Melissa Theiss summarized the projects recommended for TAP funding. Those project recommendations are available online for public comment until February 15, 2023. After the public comment period, project recommendations will be taken to the EWG Board of Directors for final approval and amendment into the TIP on March 29. EWG is planning another call for TAP projects this summer, for Missouri sponsors only. The application schedule and funding amounts are not yet final, but will likely be similar to the last cycle. No major changes to the TAP application criteria are expected.

General Directions from Missouri to parking garages

From I-70

Exit at the new Tucker exit into downtown. Continue south on Tucker to Walnut St., turn left on Walnut to Broadway. Make a right on Broadway to the Stadium East Garage entrance on the left.

From I-64

Exit at 6th St., left on Gratiot, left on 4th St, north four blocks to Stadium East Garage on left.

From I-44

Exit at Memorial Dr. Turn left on Walnut up to Broadway. Turn left on Broadway to Stadium East Garage entrance.

From I-55

Merge to I-44 and continue on I-44 toward downtown. Exit at Memorial Dr. Turn left on Walnut up to Broadway. Turn left on Broadway to Stadium East Garage entrance.

General Directions from Illinois to parking garage

From I-64/55 (Poplar St. Bridge)

Exit at Memorial Dr. Turn left on Walnut up to Broadway. Turn left on Broadway to Stadium East Garage entrance.

From Martin Luther King Bridge

On I-64, merge onto the MLK bridge ramp. On MO side, stay to the right, which is 3rd St. Turn left on Cole St., then left on Broadway. Continue on Broadway about ten blocks to Stadium East garage on the left.

From Eads Bridge

Exit I-64 at 3rd St. in East St. Louis. Follow the Casino Queen signs toward the riverfront to the ramps up to the bridge. On St. Louis side, continue west to Broadway. Turn left on Broadway for seven blocks to Stadium East Garage on left.
