#### CALL TO ORDER

The Board of Directors meeting was called to order by Mr. Kern, Chair with roll call attendance. He announced that this meeting would be the last one for Mr. Kupsky and Ms. Bell and thanked them for their service to the EWGCOG BOD.

#### APPROVAL OF MINUTES OF THE APRIL 26, 2023 MEETING

Motion made to approve the minutes of the April 26, 2023 meetings was made by Mr. Kupsky, seconded by Mr. Summers, all voting aye.

#### **DISCUSSION ITEMS**

### FY 2024-2027 Transportation Improvement Program – Summary of Local Project Recommendations

Jason Lange, EWGCOG, provided to the committee a brief update on the call for applications process noting that staff has completed the evaluation of the applications received as well as funding recommendations made by both the MO and IL TPC at their committee meetings. Mr. Lange mentioned that details of the recommendation have been provided to the committee for review and that local projects recommended for funding will be included in the draft FY 2024-2027 TIP to be presented at the June board meeting. The public comment period will run from June 30<sup>th</sup> through August 2<sup>nd</sup>, with final approval by the board at their August 30<sup>th</sup> meeting.

#### **Upcoming Funding Programs S5310, Transportation Alternatives Program (TAP)**

Melissa Theiss, EWGCOG, provided to the committee an update of the TAP federal funding requirements, evaluation process, funding descriptions, and the solicitation process (open to MO only at this time). Ms. Theiss mentioned that webinars and workshops were held April 28<sup>th</sup> and May 2<sup>nd</sup> to provide assistance with the application process, and a June workshop is currently being planned to further assist with that process; all materials are available online. She noted that the current plan had been updated in May and that the final presentation will be provided for approval at the January 2024 meeting.

#### **ACTION ITEMS**

#### **Regional Crime Summit**

Jim Wild, EWGCOG, provided the committee a request to apply for inclusion in a practicum conducted by the Violence Reduction Center (VRC). He also thanked the board members for their participation in the Crime Summit noting that there were 140 attendees. He pointed out that the conversations, presentations, and panels were well received, stressing the requirement to develop a crime analysis from crime reports/data and interactions with law enforcement. Mr. Wild noted that the general consensus at the end of the summit was that the region pursue a free of charge program to develop a violent crime reduction strategy with Thomas Abt and the VRC.

Board members cited various opinions, concerns, and comments ranging from amount of resources necessary to accomplish tasks, parallel strategies for eliminating poverty and violence, concentration of the problem, possible transferring/incorporating documentation from previous analyses and reports, regional law enforcement assistance strategy, analysis and effectiveness of time utilized by law enforcers, as well as giving the correct and straightforward perspective to solve the problem. Chairman Kern noted positive dialog resulted from the crime summit, and pointed out the importance of the region working together as a team in fixing the problem.

Mr. Wild noted that although the practicum will be free of charge, there will be some associated costs for the crime analysis of which there is available funding; there may be some funding requests forthcoming in the months ahead.

Staff recommends board approval to be given to the Executive Director to apply to the Violence Reduction Center for a multi-day event for the development of a Regional Violent Crime Reduction Strategy.

Motion to recommend approval of staff's recommendation was made by Mr. Simmons seconded by Ms. Jones. Motion carried, all voting aye.

### Approval to Amend Consultant Agreements for Additional Services for Agency Accounting/Financial Management System

Jim Wild, EWGCOG, presented the committee with a request from staff to amend the previously approved accounting/financial management system consultant agreements allowing for additional services. He noted that additional functionality support and assistance is necessary for the new system in the day-to-day fiscal operations. He pointed out that the same consultants will be retained for these additional costs and services.

Staff recommends board approval to amend consultant agreements for additional services of the Agency accounting/financial management system, and that authorization to negotiate and execute agreements be given to the Executive Director.

Motion to recommend approval of staff's recommendation was made by Ms. Days seconded by Mr. Kupsky. Motion carried, all voting aye.

#### 2023 Regional System Reliability Targets

Christie Holland, EWGCOG, presented the committee with a brief background of the State DOTs and MPOs responsibility for establishing federally-required performance targets that ensure resources are being invested in transportation projects that make progress toward achieving national goals for system reliability. Ms. Holland mentioned that DOTs and MPOs are given separate responsibilities for establishing performance targets and that MPOs can choose to adopt the state DOT targets or adopt their own. She noted that EWG has chosen to review state targets and plan to set and adopt regional targets based on regional trends, and briefly discussed the process for establishing targets.

Staff recommends board approval of the 2023 performance targets for system reliability.

Motion to recommend board approval of staff's recommendation was made by Mr. Brinker seconded by Ms. Days. Motion carried, all voting aye.

#### 2023 Regional Pavement & Bridge Performance Targets

Christie Holland, EWGCOG, presented the committee with federal requirements for DOTs and MPOs to establish performance targets and measures to achieve desired outcomes across the transportation system ensuring that resources are being invested in transportation projects that make progress toward the achievement of national goals. Ms. Holland noted that EWG has chosen to review state targets and plans to set and adopt regional targets based on regional trends, and briefly discussed the process for establishing pavement and bridge targets. She also noted that staff consulted with both IDOT and MoDOT on upcoming levels of investment and priorities in preservation and looked at historical trends to establish 2023 and 2025 targets for bridge and pavement condition.

Staff recommends board approval of the 2023 performance targets for pavement and bridge performance targets.

Motion to recommend board approval of staff's recommendation was made by Mr. Elam seconded by Mr. Kupsky. Motion carried, all voting aye.

## Modifications to the FY 2023-2026 Transportation Improvement Program (TIP), Connected 2045, and the Related Air Quality Conformity Determination – Requested by Illinois and Missouri Sponsors

Jason Lange, EWGCOG, provided the committee with requests from the Illinois Department of Transportation (IDOT) and the Missouri Department of Transportation (MoDOT) to amend the TIP by adding three new projects, modifying five projects, and delay one project. The project summary is as follows:

Staff recommends board approval to amend the FY-2026 TIP, Connected 2045, and related Air Quality Conformity Determination as requested by Illinois and Missouri sponsors.

Motion to recommend board approval of staff's recommendation was made by Mr. Kupsky seconded by Ms. Days. Motion carried, all voting aye.

#### **Regional Security Expenditures**

Kristen Capps-Jones, EWGCOG, presented to the committee staff's request authorizing expenditure of funds in support of regional security that will improve the region's disaster preparedness and response capabilities for the following: 24-month renewal of CLEAR PRO online investigation software for eight users; 12-month sub-award agreement with St. Charles County, MO supporting the Regional Cybersecurity Coordinator position; the purchase of 20 Avon respiratory equipment masks for the St. Clair County Sheriff's Department; the purchase of nine Avon respiratory equipment systems for the St. Louis County Police Department; and, the purchase of two handheld, portable high pressure mass spectrometer systems for the St. Louis County and Jefferson County Hazardous Materials Response Teams for a total amount not to exceed \$599,282 from the UASI grant program.

Staff recommends board approval authorizing expenditure of funds from the UASI grant in support of regional security that improve the region's disaster preparedness and response capabilities.

Motion to recommend board approval of staff's recommendation was made by Mr. Simmons seconded by Mr. Elam. Motion carried, all voting aye.

#### OTHER BUSINESS

Mr. Wild announced that MoDOT is looking to change its policy regarding federal funding balances for locally sponsored projects. Under the current policy, year end balances cannot exceed a total of three years of allocation, but MoDOT is considering reducing the amount the year available only; essentially a "use it or lose it" situation. He pointed out that the Council is working with MoDOT in order to avoid losing funding and encouraging sponsors to implement projects and obligate funding as soon as possible. He mentioned that as staff works through the process with MoDOT potential options and approaches will be presented to the Board at their June meeting.

Chairman Kern announced that the NASCAR CUP Enjoy Illinois 300 will take place in Madison, IL.

Motion to adjourn the meeting was made by Mr. Laker seconded by Mr. Grogan. Motion carried, all voting aye.

Date: June 15, 2023

Each year the Board of Directors adopts a Transportation Improvement Program (TIP) that allocates federal funds to transportation projects. The program comprises the first four years of projects and strategies in the regional long-range transportation plan. Before a project is eligible to receive federal funds, it must be included in the TIP.

The draft FY 2024-2027 TIP has been developed using priorities, procedures, and policies approved by the Board of Directors through the adoption of the long-range transportation plan. Staff have worked with project sponsors, funding agencies, and advisory committees to develop the recommended program of projects.

#### **Total Program Summary**

The draft TIP contains 785 new and previously programmed projects totaling nearly \$3.69 billion. The majority of these projects (642) are currently programmed in the FY 2023-2026 TIP and are presented for "reprogramming." With some adjustments, due primarily to revisions in project cost estimates and schedule modifications, all of the projects proposed by sponsors to retain their program status are recommended for reprogramming. The draft TIP excludes the Illinois Department of Transportation (IDOT) program at this time.

#### **IDOT Program Summary**

As of this date, the IDOT program has not been released by the Governor. If the program is released prior to the Board meeting on June 28, it will be included in the draft TIP when it is released for public comment. The listing of IDOT projects will also be sent to the EAC and Board. If the program is released by the Governor after June 28, then the IDOT program will be released for public comment as a standalone document.

#### **MoDOT Program Summary**

The Missouri Department of Transportation's (MoDOT) proposed program contains 241 projects at a total cost of \$1.86 billion. This includes 205 reprogrammed or rescheduled projects and 36 new projects. Road and bridge projects sponsored by MoDOT have been reviewed and are included in the draft TIP as submitted.

MoDOT's total program designates 54 percent of the program for preserving the existing infrastructure. Nearly 24 percent of MoDOT's funding will address operational and safety needs and seven percent to projects that add capacity to the system. The remaining 15 percent of MoDOT's total program is allocated for projects such as studies, set asides, pedestrian improvements, and payback projects including bonds for the Mississippi River Bridge, Safe and Sound Bridge Improvement Program, and I-64 reconstruction.

MoDOT's program includes 107 scoping projects. MoDOT's scoping policy ensures projects have defined scopes and construction costs before they are committed to the TIP. If revenues increase and construction funding is available, scoping projects may be added to the TIP as new projects in the future.

#### **Transit Program Summary**

In Missouri and Illinois, 182 transit projects (163 reprogrammed and 19 new) were submitted for programming. The total cost of the transit projects is \$1 billion.

Bi-State Development/Metro's proposed program consists of 77 projects at a total cost of \$977.1 million. This includes \$96 million for extension of MetroLink from Scott Air Force Base to Mid America Airport which will be administered by St. Clair County Transit District. The program submitted by the Madison County Transit District contains 34 projects at a total cost of \$52.6 million. The majority of funding in Bi-State Development/Metro's and Madison County Transit District's programs comes from Federal Transit Administration Section 5307 funds.

The other 71 projects in the transit program (\$10.2 million) are sponsored by not-for-profits and other transit agencies. The program includes projects funded through the Section 5310 Program (Enhanced Mobility of Seniors and People with Disabilities).

#### **Summary of Local Programs**

The Missouri and Illinois Transportation Planning Committees made recommendations on new locally sponsored projects in May. The recommended projects were presented to the Executive Advisory Committee and the Board of Directors for their consideration prior to inclusion of the projects in the draft TIP.

The proposed local Illinois program contains 140 projects (103 reprogrammed and 37 new) at a total cost of \$242.7 million. The 37 new projects have a total cost of \$76.7 million (\$54.3 million in federal funds).

The proposed local Missouri program contains 222 projects at a total cost of \$787.1 million. Included are 171 reprogrammed projects and 51 new projects. The 51 new projects have a total cost of \$163 million (\$105.3 million in federal funds).

#### **Major Project Summary**

Out of the 785 projects in the draft TIP, 17 projects (excluding paybacks) have programmed costs (including engineering, right-of-way acquisition, and construction) that have programmed costs greater than \$35 million. These projects account for 29 percent of the total program and are summarized on the following table:

#### **Fiscal Constraint**

The TIP is required to be fiscally constrained, with reasonable assurance that funds will be available to implement the proposed projects in a given year. Staff has evaluated the federal funds programmed in the TIP regarding amounts authorized in federal legislation and anticipated federal spending limitations. The proposed federal funding levels for the entire program do not exceed the funds anticipated to be available in the various program years.

The state DOTs, transit agencies, and local sponsors have incorporated inflation factors into the cost estimates for their projects that are expected to be implemented beyond the first year of this TIP. Further, each of the local implementing agencies has submitted written certification indicating that non-federal matching funds are available for their respective projects. In this way, there is some assurance that proposed projects represent true commitments on the part of local agencies rather than project "wish lists."

#### **Air Quality Conformity Analysis**

Since the St. Louis region is designated as a non-attainment area for air quality, the TIP must be analyzed to determine its conformity with air quality plans and objectives. This analysis is ongoing and expected to be completed by June 27, 2023.

#### **Public Participation**

The public comment period begins on Friday, June 30, 2023 when the TIP and Air Quality Conformity Determination documents are posted to the East-West Gateway website and will close Wednesday, August 2, 2023. The documents, as well as explanatory charts and maps, will be available for download on the website throughout the comment period. The documents will also be available at five public open house meetings in July. Staff and project sponsors will be available to answer questions about the TIP and Air Quality Conformity Determination during the open house meetings. Open house meeting locations will be posted to the East-West Gateway website once locations are finalized. A summary of the TIP and Air Quality Conformity Determination documents and comment forms will be posted to the East-West Gateway website.

Information regarding the public comment period will be posted on the Council's website, *Local Government Briefings* newsletter, Facebook and Twitter pages, and advertised in local newspapers.

The Air Quality Conformity Determination and Documentation will be available at the start of the public comment period on Friday, June 30, 2023.

**Approval of Final FY 2024-2027 TIP and Air Quality Conformity Determination** Following the public comment period, staff will bring the Final FY 2024-2027 TIP and Air Quality Conformity Determination to the Board of Directors in August for final approval. If IDOT's program is not included in the final TIP then a separate Board action will be needed to amend the TIP to include the IDOT program.

Subject: Auditor Services for Audit Years 2023 and 2024

Date: June 21, 2023

Each year EWG is required to have a Single Audit of its financial statements and an indirect cost rate audit performed in accordance with 2 CFR Part 200. In 2020, EWG issued an RFP for audit services for the years ending December 31, 2020 through December 31, 2022, with the option to extend the contract for two 1-year terms for the years ending December 31, 2023 and December 31, 2024. In February 2021, the Board authorized EWG to contract with Kerber, Eck, and Braekel (KEB) for audit services for each of the audit for the years 2020 through 2022, with an option to extend the contract for a 1-year term for each of the 2023 and 2024 audit years.

KEB has been selected as EWG's independent auditor since audit year 2012 and has continued to provide us excellent service during this time. The State of Missouri does not have requirements that govern how frequently an auditor's service must be resolicited or have mandatory audit firm rotation rules; however, the Government Finance Officers Association (GFOA) recommends that governmental entities re-solicit auditor services every 5 years. GFOA also discourages the use of mandatory auditor rotation policies because the limited pool of audit firms fully qualified to conduct public sector audits makes such policies counterproductive. GFOA's recommendation to utilize multi-year contracts of 5 years is based on several factors including: maintaining continuity of service, minimizing disruption in the conduct of the independent audit, and the reduction of audit costs. The GFOA also suggests that if the same audit firm is retained after a competitive procurement process, then management should consider requesting that senior audit partners or managers at the audit firm be rotated to provide a new perspective. Based on this recommendation, EWG is seeking to retain KEB for the 5-year service term that we originally procured in 2020/2021. Following the end of this term, EWG will again solicit proposals from audit firms for the next 5-year term.

Subject: Amendment to the FY 2024 Unified Planning Work Program

In April 2023, the Board of Directors approved EWG's FY 2024 Unified Planning Work Program (UPWP) which describes all of the planning work that EWG and other local agencies will undertake during the fiscal year. Periodically, the UPWP may be amended to include new funding sources and projects or revisions to current projects described in the UPWP. EWG will receive funds from U.S. Environmental Protection Agency (EPA) to produce a climate action plan for the St. Louis MSA. We are requesting that the Board approve an amendment to the FY 2024 UPWP to add one work element to include these new activities and products. The changes are described below and the new work element is attached to this memo.

**3.04** Climate Pollution Reduction Grant (CPRG) - The EPA is providing EWG funding to produce a Climate Action Plan for the St. Louis Metropolitan Statistical Area to reduce emissions of carbon dioxide, other greenhouse gases, as well as criteria air pollutants. This work element involves developing a Climate Action Plan, which requires a detailed analysis of current and future air pollution emissions, engagement across the St. Louis MSA with extra effort to reach low income and disadvantaged communities, identification of projects that reduce air pollution, and an analysis of the health and economic impact of such projects. Upon completion of work products under the grant, all local municipal and county government agencies in the St. Louis, MO-IL MSA will be eligible to apply for CPRG implementation funding. The St. Louis MSA is one of 81 MSAs receiving a grant through the CPRG program. The CPRG work will continue over multiple fiscal years; estimated to begin in FY 2024 and to continue through FY 2028.

#### **Staff Recommendation**: Staff recommends that:

- The FY 2024 UPWP be amended to include work element 3.04.
- The Executive Director be authorized to negotiate and execute the funding agreements, grant agreements, and financial assistance sub-awards that are necessary to complete the work that is outlined in the work element.

Approval of the Final Air Quality Conformity Determination and Subject:

> Documentation and Adoption of the Long Range Transportation Plan Update, Connected 2050 and State of the System Technical Supplement

Date: June 15, 2023

Federal law requires that the Council update the region's long-range transportation plan every four years. The last plan, Connected 2045 update was adopted by the EWG Board of Directors on June 26, 2019.

Connected 2050 is a long-range vision for how our region's transportation system will develop over the next 26 years. All transportation projects using federal funds must be identified in the long-range plan, or be consistent with the plan's principles. This plan, with the horizon year of 2050,

- outlines twelve principles to guide regional transportation decisions,
- identifies strategies to direct transportation system evaluation and decisionmaking,
- defines the region's capacity to finance major transportation improvements,
- identifies priority projects that can be funded within the region's anticipated financial resources, and
- establishes the conformity between the plan and state/regional air quality goals.

Connected 2050 identifies \$31.2 billion in recommended investments between 2024 and 2050, including approximately \$24.5 billion in highway and transit preservation spending, and over \$6.7 billion for 46 major transportation projects. All recommended investments fit within the plan's fiscal constraint. The plan also includes five illustrative projects and several corridors where improvements may be warranted and further study is recommended. All cost and revenue estimates are in year of expenditure (YOE) dollars.

The State of the System Technical Supplement to Connected 2050 details the analysis that went into the plan's development and highlights the Council's transportation planning activities.

Finally, staff conducted an Air Quality Conformity Determination as part of the development of Connected 2050. In accordance with the Clean Air Act Amendments of 1990 and related Federal regulations, the long-range plan must be found to be in conformity with all applicable State Implementation Plans (SIPs) and with the mobile source emissions budgets as established by the SIPs before the long-range plan may be approved by the MPO and the Federal Highway Administration. Based on the conformity analysis conducted for the applicable ozone standards, Connected 2050 has been found to be in conformity with all relevant federal and state conformity regulations.

Staff presented the Draft Connected 2050 to the EAC and Board of Directors in April. A public comment period was held from May 8, 2023 to June 7, 2023. Staff held four community pop-up events (one in Illinois and three in Missouri) along with two virtual webinars to solicit comments from the public during the comment period. Information was also available on the EWG website where citizens could review the plan and leave comments. These activities were advertised on social media, in local newspapers, and in EWG's weekly Local Government Briefings e-mail blast.

A summary of the public comments received is provided as an attachment to this memo. Changes made to the draft plans as a result of comments include the addition of

- information on historical transit services in the Metro East in Chapter 1 of the Long-Range Transportation Plan,
- an indicator to show which projects have bicycle and pedestrian facility components in Chapter 5 of the Long-Range Transportation Plan, and
- content on historical transportation funding and a breakdown of spending by county in the EWG region in Chapter 18 of the State of the System.



Beyond comments on projects, key themes that emerged in the public comments include:

- Concerns that the plan is overly focused on moving automobiles with not enough focus on walking and biking. Six comments noted disappointment that most projects were focused on improving driving. Seven comments stated that the plan needed a greater focus on walking and nine comments stated that the plan needed a greater focus on biking.
- Concerns about pavement conditions and potholes. Four comments focused on the poor condition of existing roads. Three comments noted concerns about local roads in St. Louis City and one comment noted concerns about local roads and interstates in St. Clair County (particularly near East St. Louis).
- Concerns about safety on public transit. Some commenters noted that they feel safe while riding transit while other expressed fear about safety. One comment stated that the individual was not in support of metro's secure platform plan.

- Need for more parking amenities near Forest Park and other cultural centers. One comment noted that taking transit to parts of Forest Park was challenging and that more parking options are needed.
- Concerns about road condition during project construction. Several commenters noted concerns about congestion and road condition during construction of projects. One comment cited poor road conditions on I-270 in North St. Louis County as an example.

Additionally, some commenters proposed projects not in the plan:

- Extension of 21 as a limited access freeway from Hillsboro to DeSoto in Jefferson County
- Removal of I-44 between the Poplar Street Bridge and the Stan Musial in St. Louis City to reduce traffic and have downtown St. Louis connected to the Arch and Laclede's Landing.
- Safety, noise, and pollution improvements on South Broadway in St. Louis City
- Improvement of I-64 interchanges and ramps in St. Clair County (particularly near East St. Louis)

Finally, some commenters focused on the contents of the long-range plan document.

- Lack of trust in plan. Two commenters expressed that they did not trust the plan. One noted that they "Do not trust [the plan] just a way to waste money". Another commenter felt their community does not have power to influence transportation projects.
- **Vague goals.** One comment noted, "It seems very detailed but I was disappointed to see a lack of clearly defined goals. It all seems very general vague which makes progress difficult to track. I'd like to see more clearly defined goals as opposed to abstract ones"
- **Chapter 1 historical context.** One community pop-up attendee suggested increasing focus on the Metro East in the historical context section.

In April 2010, the Board of Directors approved a modification to the one-time schedule change allowed by the Policy on Reasonable Progress. The change allowed sponsors to request, no later than June 1, a one-time extension. It gave staff authority to grant extensions up to three months and required Board action on extension requests of three to nine months.

To be considered for this one-time extension, the sponsor has to demonstrate: a) the delay is beyond their control and the sponsor has done diligence in advancing the project; b) federal funds have already been obligated on the project, or in cases that no federal funds are used for preliminary engineering or right-of-way (ROW) acquisition, there has been significant progress toward final plan preparation; and c) there is a realistic strategy in place to obligate all funds within the extended time.

As of the June 1 deadline, staff received 36 eligible requests for schedule extensions beyond the September 30, 2023 suspense date. The amount of federal funds programmed for these projects is \$49.5 million. Of the 36 requested schedule extensions, four were for a three-month extension and the remaining 32 were for a ninemonth extension.

Among the extension requests, staff has identified nine projects with \$9.1 million in federal funds that could likely make the September 30, 2023 deadline. Staff will continue to work with these sponsors to ensure as many projects as possible can obligate federal funds in Fiscal Year (FY) 2023.

The remaining 43 projects with construction funds programmed in FY 2023, representing \$44.4 million in federal funds, are on schedule to obligate funds by September 30, 2023. Last year, East-West Gateway received 34 requests for extensions totaling \$38.9 million. Staff will continue to monitor all projects according to the schedule indicated in the project application and provide updates if issues arise.

#### **Nine-month Extension Requests**

**Table 2** details the 32 projects recommended to receive a nine-month extension, which requires Board action. Staff has reviewed these projects to determine if the delay is beyond the sponsor's control, if federal funds have been obligated for these projects, and if a realistic strategy is in place to obligate federal funds by June 30, 2024. Based on information provided by the sponsors and a review of the project files, staff has determined that all 32 projects have met the required tests. However, staff has identified five projects totaling \$4.8 million that could likely make the September 30, 2023 deadline. Staff is requesting authorization to expend funds in support of regional security that will improve the region's disaster preparedness and response capabilities. Funding will come from the U.S. Department of Homeland Security's Urban Area Security Initiative (UASI) grant program. Attachment A summarizes the purchases, totaling \$229.273.

### COMPLEX COORDINATED TERRORISM ATTACK (CCTA) PLANNING, TRAINING & EXERCISE

CCTA Intelligence Liaison Officer (ILO) Program – The Region's CCTA program has expanded the ILO program within the St. Louis Regional Fusion Center, building a robust prevention, intervention, and response mindset to a CCTA type incident through planning, training, and exercise. In January, the Board approved a contract award to Hagerty Consulting, Inc. to provide ILO planning, training, and exercise services. This contract included the option to conduct a virtual and a functional exercise if additional grant funds became available. These grant funds have been made available and it is the intent of the Region's first responders and St. Louis Regional Fusion Center to validate lessons learned, outputs and other measurable components from the CCTA ILO program through these exercise activities. Staff is requesting approval to expend additional funding for Hagerty Consulting to conduct an ILO virtual exercise and a Hunter Seeker ILO functional exercise to provide this validation. The virtual exercise will validate outputs from recent milestones of the CCTA ILO program, through the use of new/updated training materials and processes with recently trained ILOs. The functional exercise will include a multi-day event that will validate the engagement of frontline first responders and the St. Louis Regional Fusion Center through varying scenarios and examine the viability of ILO information processes. Each exercise will result in an After-Action Report (AAR) and Improvement Plan (IP) that will assist in guiding CCTA program enhancements and improvements. The total cost of the exercise activities will not exceed \$229,273 from the UASI grant program.
