# CALL TO ORDER

The Board of Directors meeting was called to order by Mayor Jones, Chair with roll call attendance.

# APPROVAL OF MINUTES OF THE FEBRUARY 28, 2024 MEETING

Motion was made by Mr. Elam, seconded by Mr. Simmons, to approve the minutes of the February 28, 2024, meeting. Motion carried, all voting aye.

# **DISCUSSION ITEMS**

# Draft Fiscal Year 2025 Unified Planning Work Program

Jim Wild, EWGCOG, provided the board with an update on the draft FY 2025 Unified Planning Work Program (UPWP) that was provided to the board for review and comment.

Mr. Wild explained that EWG's UPWP describes all of the planning work activities that the EWG staff and other local agencies will undertake during the 12-month period that begins July 1, 2024. The document serves as the scope of work for our grant agreements with the state and federal agencies that provide funding to support EWG's planning and related activities in the region. Mr. Wild added that metropolitan planning organizations like EWG are required to adopt a UPWP to describe the federally-funded transportation planning activities.

Mr. Wild noted that some of the activities described in the UPWP are underway and will continue into FY 2025; other projects will begin at various times during FY 2025 depending on funding availability.

Mr. Wild then summarized Section II of the UPWP, which included the funding tables that describe the sources of funds and estimated costs for the planned activities. The total funding projected for FY 2025 is \$15,167,998, with a total of \$8,866,489 estimated for new funding during the fiscal year. EWG's in-house costs are estimated to be \$7,362,720, and we estimate that \$3,400,750 will be expended to hire consultants for planning projects completed during the fiscal year, and \$3,792,700 will be passed through to or expended on behalf of other local agencies.

The FY 2025 UPWP has been submitted to IDOT, MoDOT, FHWA, and FTA for review and comment. Staff will bring the final FY 2025 UPWP to the Board of Directors for approval at

their April meeting. Comments on the Draft FY 2025 UPWP will be accepted through April 8, 2024.

# **Comprehensive Safety Action Plan -** *Gateway to Safer Roadways*

Shawn Leight, CBB, provided the board with an update on the Gateway to Safer Roadways Comprehensive Safety Action Plan. Mr. Leight discussed the background of the issue noting roadway crashes are the leading cause of death for those 8-20 years of age in the United States. The St. Louis region ranks above its peer regions in fatal crashes per 100 MVM. The EWG region experiences about 1,915 fatal and severe crashes per year. As such the *Gateway to Safer Roadways* is developing a regional Safety Action Plan focusing on national best practices, engagement, and safety analysis.

Mr. Leight noted that data shows how and where the main contributing causes to roadway deaths and injuries are, and with this, we are able to create focused strategies. Data shows that we can reduce roadway crashes through better laws, roads, and education programs.

Mr. Leight briefly described the upcoming deadlines related to the Notice of Funding Opportunity (NOFO) released in February. These dates and descriptions can be found on the EWGCOG website March EAC meeting materials.

Mr. Leight discussed the project timeline and next steps. The project started in November 2023 and is planned to be completed by July 2024. They are currently in the data analysis phase. Work will begin shortly to finalize the safety analysis, developing recommendations, and preparing the report.

Five county stakeholder groups and a Regional Safety Task Force were formed to help the development of the plan and keep our safety stakeholders informed. The groups have met twice since January and will meet a third time to review the draft plan from April 29 to May 3. The Draft Safety Action Plan will be presented at the May EAC and BOD meetings, and the final plan will be presented for approval in June.

# FY 2025-2028 Transportation Improvement Program - Submitted Local Project Applications

Alex Harting, EWGCOG, provided the board with an update on the Transportation Improvement Program for FY 2025-2028. Each year, EWG staff present a summary of local applications that were submitted for funding consideration. No recommendations have been made as Council staff are in the process of evaluating applications. Mr. Harting discussed that East-West Gateway released a call for applications on November 3, 2023, for the available funding programs: the Surface Transportation Block Grant Program– Suballocated (STP-S), Missouri Off-system Bridge Program (BRO/BFP), Carbon Reduction Program (CRP), and Congestion Mitigation and Air Quality Improvement (CMAQ) projects. These project applications were due on February 8, 2024. Mr. Harting gave a brief overview of the project applications by type and state. He referred board members to the provided memo for a more detailed overview. The Illinois sponsors submitted 24 STP-S applications requesting \$19.1 million and 8 CMAQ applications requesting \$6.1 million. The Missouri sponsors submitted 65 STP-S applications requesting \$129.6 million and 17 CMAQ applications requesting \$44.7 million. The CRP projects will be selected from CMAQ applications. Bridge (BRO/BFP) projects will be selected from eligible MO STP-S bridge applications. Mr. Harting reminded the board that these are only submitted projects, and not the recommendations.

The estimated funding availability is approximately \$7.5 million for STP-S IL and \$65 million for MO. For CMAQ, available funding was estimated at \$6 million IL and \$33 million MO. CRP was estimated at \$1.8 for IL and \$10 million for MO. Bridge (BRO/BFP) funding is estimated at \$6 million for MO and was not applicable for IL.

Mr. Harting then reviewed the upcoming project timeline noting that staff are currently in the process of evaluating the submitted projects. The local project recommendations will be presented to the Transportation Planning Committee (TPC) in early May. The projects chosen by TPC will be presented to the EWG EAC and BOD in late May.

The recommended local projects will be included in the draft FY 2025-2028 Transportation Improvement Program (TIP), which will be presented to EAC and the Board of Directors during the June meeting. Next, the TIP will be released for public comment from June 28 through August 1. Once the public comment period concludes, EWG will summarize the comments and submit the TIP for final approval at the August Board meeting.

# ACTION ITEMS

Mayor Jones noted that because agenda item A: St. Louis Region's Plan to Plan for Violence Reduction will require much discussion, the board will begin with item B: Resolution to Approve / Adopt Title VI Program and move item A to the last item of the Action Agenda.

# **Resolution to Approve / Adopt Title VI Program**

Jim Wild, EWGCOG, presented the board with the Council's 2024 Title VI document. Mr. Wild pointed out that as a federal aid recipient, EWG is required to develop a Title VI program that demonstrates how the agency will ensure compliance with non-discrimination requirements.

Mr. Wild noted that this document has been out for public review and comment between February 7 and March 8. Additionally, EWG held two public meetings on February 27 and March 4 to take comments and answer questions. Staff did not receive any comments on the draft 2024 Title VI Program.

Mr. Wild noted the requirement to provide a resolution that outlines the Council's approval and adoption of the Title IV Program. This resolution would 1) approve/adopt the 2024 Title VI Program, (2) authorize for the Executive Director to sign the Title VI Assurance, and (3) authorize the Executive Director to make certain minor changes to the 2024 Title VI Program.

Motion to recommend board approval of staff's recommendation was made by Mr. Simmons seconded by Mr. Schwind. Motion carried, all voting aye.

### **Regional Security Expenditures**

Samantha Lewis, EWGCOG, provided the board with three requests to expend funds in support of regional security. Requests are as follows: Intelligence Analyst Position and Regional Cyber Security Coordinator Position to be renewed from July 1, 2024 through June 30, 2025. One handheld, portable high-pressure mass spectrometer system for the City of St. Louis Fire Department's hazardous materials response team.

The staff recommends that the board approve a suborn agreement for the Intelligence Analyst Position, the Cyber Security Coordinator Position, and the purchase of one handheld mass spectrometer, the total amount of which shall not exceed \$312,700 from the UASI grant program.

Motion to recommend board approval of staff's recommendation was made by Mr. Laker seconded by Ms. Green. Motion carried, all voting aye.

### St. Louis Region's Plan to Plan for Violence Reduction

Jim Wild, EWGCOG, provided the board with a summary of the Crime Summit held in May 2023, resulting in board approval for the Council to become involved with the Violence Reduction Center (VRC) and to conduct a Practicum held December 4-8, 2023 that led to developing a Violence Reduction Plan.

Mr. Wild pointed out that the week-long practicum included a working group of 30 experts including elected officials, police, prosecutors, intervention specialists, and community representatives from across the region. As a result of that effort, the VRC developed a strategy named "amend SAVING LIVES, STOPPING VIOLENCE: THE ST. LOUIS REGION'S "PLAN TO PLAN" FOR VIOLENCE REDUCTION," which Mr. Wild explained as a blueprint that identifies key strategies, structure, and capacity-building measures that would help guide the region on a general direction and approach to battling violent crime and gun violence in the St. Louis region.

Mr. Wild pointed out the three key programs in the blueprint: Focused Deterrence, Cognitive Behavioral Therapy, and Street Outreach. Five capacity-building measures outlined in the document including adding a new anti-violence collaborative department at EWG, launching a regional implementation team, expanding regional homicide analysis, building regional capacity, and establishing an Anti-Violence Advisory Board. In response to an inquiry made during the January Board meeting, Mr. Wild shared the preliminary Advisory Board roster and noted that it is still under development as individuals are being contacted. More information is provided in the St. Louis "Plan to Plan" for Violence Reduction document provided in January. This was

supplemented with a Save Lives Now! Blueprint for the Collaborate Anti-Violence Program which, which helped explain the approach and structure more concisely.

Mr. Wild recapped how the board took action in January on different components of the "Plan to Plan" recommendations, specifically hiring and supporting staff (including a Director), conducting procurements, and serving as the fiscal agent authorizing(including accepting contributions to help fund the effort). Staff were also authorized to organize and manage the Regional Implementation Team and support data collection and analysis. He noted that \$75,000 in contributions had been pledged during the practicum, and recently one of those contributors committed an additional \$50,000. Mr. Wild is meeting with several other funders who are interested in this initiative.

After a discussion on Thomas Abt's book, Mr. Ehlmann provided board members a handout with his motion to amend SAVING LIVES, STOPPING VIOLENCE: THE ST. LOUIS REGION'S "PLAN TO PLAN" FOR VIOLENCE REDUCTION, page 7; line 18; by deleting, "the Mayor of the City of St. Louis and the St. Louis County Executive," and replacing it with, "two members of the Executive Committee of the EWGCG Board of Directors, one from Missouri and one from Illinois, one representing each side of the debate identified by Thomas Abt over the two philosophies on reducing criminal violence: "Those suspicious of authority and believe criminality is created by root causes" and the other one of "those who trust authority and demand accountability for criminal acts." *Bleeding Out*, p.48. Mr. Ehlmann moved to further amend page 7, line 19, after the word "collaborative," by adding, "and a crime data analyst, preferably Professor Ness Sandoval of St. Louis University." Following discussion a roll call vote was held. Seven ayes, eleven nays; the motion failed.

Mr. Ehlmann provided board members a handout with his motion to amend SAVING LIVES, STOPPING VIOLENCE: THE ST. LOUIS REGION'S "PLAN TO PLAN" FOR VIOLENCE REDUCTION, page 7, line 20 by adding at the beginning of said line "One half of" and further amend such line by deleting the word "included," by deleting "membership should be spread roughly evenly across these three groups." Following discussion a roll call vote was held. Seven ayes, eleven nays; the motion failed.

Mr. Ehlmann provided board members a handout with his motion to amend SAVING LIVES, STOPPING VIOLENCE: THE ST. LOUIS REGION'S "PLAN TO PLAN" FOR VIOLENCE REDUCTION, page 7, line 27, after the word "press." By adding, "All meetings and all documents of the board or any subcommittees it may create shall be subject to Chapter 610 RSMo." Further amend page 8, line 4, after the word "meetings," by deleting "should be closed to the public and press" and substituting "shall be open and subject to Chapter 610 RSMo." Following discussion a roll call vote was held. Six ayes, twelve nays; motion failed.

Mr. Ehlmann provided board members a handout with his motion to amend page 9, line 9, after the word "lives." By adding, "Before the first social worker or each additional social workers is

hired by the collaborative, the City of St. Louis must hire ten new police officers." After discussion, Mr. Ehlmann withdrew his amendment.

Mr. Ehlmann provided board members a handout with his motion to amend page 9, line 9, after the word "lives." By adding, "Before the first social worker or each additional social workers is hired by the collaborative, the City of St. Louis must hire one new police officer." Following discussion a roll call vote was held. Four ayes, fourteen nays; motion failed.

Motion to recommend board approval of staff's recommendation with roll call vote was made by Mr. Simmons, seconded by Ms. Jones. Thirteen ayes and five nays; motion passed.

### ADJOURNMENT

Motion to adjourn the meeting was made by Mr. Elam seconded by Mr. Simmons. Motion carried, all voting aye.

FY 2024 Reasonable Progress Update – March 2024

April 10, 2024

East-West Gateway's (EWG) Policy on Reasonable Progress ensures that projects funded through the local programs (i.e., Surface Transportation Block Grant Program, Congestion Mitigation and Air Quality Improvement Program, Carbon Reduction Program, and Transportation Alternatives Program) maintain the schedule as proposed in the project application. For projects or programs included in the Transportation Improvement Program (TIP), "reasonable progress" will have been made if the project has advanced to the point of obligating all federal funds programmed for that project in the current fiscal year (FY), regardless of phase of work (i.e., Preliminary Engineering (PE), Right of Way Acquisition (ROW), or Construction (CONST)). Failure to meet the Policy will result in the loss of federal funds for the project. Reasonable Progress is tracked for projects in Missouri only.

If a project is realizing delays that will put the federal funding at risk of forfeiture (i.e., will not meet the September 30<sup>th</sup> deadline), the project sponsor has the opportunity to request consideration of a one-time extension in their project schedule. This process takes place each June. One-time extensions of up to three months may be granted by EWG staff and one-time extensions greater than three months, but not more than nine months, are presented to the EWG Board of Directors for consideration and approval.

Throughout the period covered by the TIP, EWG issues reasonable progress updates within the current fiscal year that are subject to the September 30<sup>th</sup> deadline to obligate federal funds. As of March 31, 2024, there are 164 local projects in Missouri with federal funding programmed in FY 2024 of the FY 2024-2027 TIP. These projects, sponsored by 50 different agencies and representing \$124.5 million in federal funds, are subject to the September 30<sup>th</sup> deadline unless noted as already receiving a schedule extension from the prior FY.


#### FY 2024 Reasonable Progress Update: March 31, 2024

#### Policy on Reasonable Progress

In the past, the lack of progress in developing and implementing projects using federal funds suballocated to the St. Louis region has led to significant project delays and created financial risks for both local and state transportation programs. Over the last several years, the East-West Gateway Council of Governments (EWGCOG) has taken a firm stance on delinquent projects through enforcement of the Council's Policy on Reasonable Progress.

Currently, there are 164 local projects in Missouri with federal funding programmed in Fiscal Year (FY) 2024 of the FY 2024-2027 Transportation Improvement Program (TIP). These projects, sponsored by 50 different agencies and representing \$125 million in federal funds, are subject to a September 30, 2024 deadline to obligate the federal funds, unless noted as receiving a schedule extension. To obligate funds, a sponsor must obtain approval from the Missouri Department of Transportation (MoDOT) for a specific milestone. Generally, a project must meet three milestones before construction or implementation of project may begin: approval of design contract (PE), approval to acquire right-of-way (ROW), and final plan approval/authority to advertise (CONST/IMPL).

If a project is realizing delays that will put the federal funding at risk of forfeiture (i.e., not meet a September 30 deadline), the project sponsor will have the opportunity to request a "one-time extension" of their project schedule. The request for an extension is only available for projects with construction funds programmed in the current fiscal year and is due by June 1, 2024. One-time extensions of up to three (3) months may be granted by East-West Gateway staff and one-time extensions greater than three (3) months, but not more than nine (9) months, will go to the Board of Directors for their consideration and approval. If the project still cannot obligate funds after the one-time extension or the sponsor decides not to proceed, funding will be removed from the TIP, and the federal funds associated with those projects will be returned to the regional funding pool for redistribution without further action by the board.

Approval of the FY 2025 Unified Planning Work Program (UPWP) and Authorization to Enter into Agreements for Work Identified in the UPWP

April 9, 2024

In March, we provided the Board the draft FY 2025 Unified Planning Work Program (UPWP) for review and comment. The UPWP was also distributed to our funding agencies and was open for public comment March 8, 2024 through April 8, 2024. During the comment period we received comments from the Federal Highway Administration (FHWA) about formatting and adding information about the Planning Emphasis Areas (PEAs) and regionally significant research projects. To address these comments, we corrected formatting errors in work elements 1.07 and 3.02. We also updated Section I – Introduction, Part B to add information about the PEAs and we updated work element 1.07 to add examples of regionally significant topics addressed through EWG's research. In work element 2.13 we corrected the funding table; the prior version did not include MoDOT's funding in the Total section.

The UPWP describes all of the planning work activities that the staff and other local agencies will undertake during the 12-month period that begins July 1, 2024. This document serves as the scope of work for our grant agreements with the state and federal agencies that provide funding to support EWG's planning and related activities in the region.

Section II of the UPWP includes the funding tables that describe the sources of funds and estimated costs for the planned activities. The total funding projected for FY 2025 is \$15,167,998; with a total of \$8,866,489 estimated for new funding during the fiscal year. EWG's in-house costs are estimated to be \$7,362,720 and we estimate that \$3,400,750 will be expended to hire consultants for planning projects completed during the fiscal year, and \$3,792,700 will be passed through to or expended on behalf of other local agencies.

Inflationary Adjustment Policy – MO LPA Program

April 16, 2024

In January 2024, the Missouri Department of Transportation (MoDOT) announced a new goal setting approach to local program management. Under this new guidance, a target obligation percentage will be established for each year aimed at lowering the accumulation of program carryover balances. For FY 2024, MoDOT's goal is for each Transportation Management Area (TMA) to obligate 120% of its annual allocation (approximately \$108 million for East-West Gateway). In addition to this goal, there is also a "trigger point" where if the obligation percentage falls under 110% (or \$99 million for East-West Gateway) at the end of the fiscal year, the funds will expire from the local program and be obligated on the state program. For reference, in FY 2023, East-West Gateway obligated 121% of its annual allocation (or \$109 million), and statewide the Local Public Agency (LPA) program obligated a share of 111%. The targets for FY 2024 are shown in the table below.

FY 2024 Targets	
120% Target	\$107,987,710
110% Trigger Point	\$98,988,734

Currently, there is \$124 million programmed in FY 2024. Taking into account projects that could advance from future years (\$24 million), the potential of projects dropping and returning funds (\$18 million), and estimated likely project extensions or delays (\$32 million), the total federal cost of projects that are reasonably expected to obligate in FY 2024 is around \$98 million, which is slightly below the trigger point. Any unforeseen circumstances or project delays could mean that LPA funds would expire.

Earlier this month, the Missouri Transportation Planning Committee (TPC) recommended the approval of a temporary measure to increase funding on projects that are experiencing inflationary issues. This includes utilizing up to \$10 million to be used before the end of calendar year (December 31, 2024) or when the money is fully expended, whichever occurs first. The \$10 million figure represents roughly the difference between the 110% and 120% obligation targets. There would be no fiscal impact to FY 2024, but using these funds for this purpose could mean there would be less funding available in later years, depending on whether projects that are at risk of dropping actually do or the estimated extension requests are higher or lower than predicted.

Below are the parameters approved by the Missouri TPC - -

- Approval will be issued first-come, first-served, and the additional funds provision ends either when the \$10 million is expended or at the end of this calendar year, whichever comes first.
- Only available for LPAs to be used on projects funded with Surface Transportation Block Grant Program (STP-S), Congestion Mitigation and Air Quality Improvement Program (CMAQ), or Transportation Alternative Program (TAP). Additional funding for CMAQ projects may be limited due to lower program balances.
- Additional funding granted only for items in the approved application scope.
- Additional funding for the construction phase only, and the request will occur during Bid Concurrence.
- The increase is based on the federal matching percentage (for construction only) provided by the sponsor in the Transportation Improvement Program (TIP) application, not the rate in the program agreement.
- One sponsor cannot receive more than \$3,000,000 in additional federal funds.
- The amount for each eligible project will be no less than \$50,000 federal, and no more than \$1,000,000 federal.

On April 16, 2024, the Executive Advisory Committee (EAC) approved the one time inflationary cost adjustment including the above parameters, but with the following revisions:

- Approval will be issued first-come, first-served, and the construction funds must be obligated by September 30, 2024 and Bid Concurrence must occur prior to December 31, 2024.
- The amount for each eligible project will be no less than \$50,000 federal, and no more than \$1,000,000 federal, or 30% over the original estimate in the TIP application, whichever is lowest.

If approved, this measure would go into effect immediately. Staff will provide monthly reports to the Missouri TPC, EAC, and Board of Directors on the progress of this temporary measure.

#### Staff Recommendation:

Staff recommends approval of a temporary measure to increase funding on projects that are experiencing inflationary issues according to the parameters approved by the Missouri TPC and revised by the EAC.

Approval of the Coordinated Human Services Transportation Plan (CHSTP)

April 9, 2024

In May 2020, the East-West Gateway Board of Directors adopted the current Coordinated Human Services Transportation Plan (CHSTP) for the St. Louis Region. The CHSTP is a regional planning tool designed to help guide the investment of Federal Transit Administration (FTA) Enhanced Mobility of Seniors and Individuals with Disabilities (Section 5310) funding. Federal law requires the CHSTP to be updated at least every four years and that projects selected for funding through the Section 5310 Program be "included in a locally developed, coordinated public transit-human services transportation plan." Regular updates allow the St. Louis Region to retain its eligibility to receive federal funding through the Section 5310 Program and to address the mobility needs of seniors and individuals with disabilities.

The CHSTP must include four key elements: 1) an inventory of existing transportation services in the St. Louis region, 2) an assessment of the transportation needs of seniors and individuals with disabilities, 3) strategies to address the gaps between existing services and the needs assessment, and 4) priorities for implementing the identified strategies. Staff has developed the update to the CHSTP with assistance from 28 individual stakeholders and 41 different agencies across the region that serve the needs of seniors and individuals with disabilities. This includes public, private, and non-profit transportation and human service providers in Missouri and Illinois. Based on local stakeholder input, the CHSTP identifies five gaps or areas of unmet needs: Affordability, Reliability, Coordination, Environmental and Social, and Technology. The CHSTP also identifies 31 strategies – prioritized as high, medium, or lower priority – that can be implemented in the region to help address and mitigate these gaps.

The draft CHSTP was presented to the TPC, EAC, and Board of Directors in February 2024. It was made available on the East-West Gateway website on March 1, 2024 and was open for public comment from March 1 through March 31. Two comments were received during this period. Open houses for the draft CHSTP were held in person at the Glen Carbon Senior Center on March 7 from 1:00-3:00 pm and the Jim Tuscher Auditorium at Paraquad on March 22 from 1:30-3:00 pm. Subject: Functional Classification Update

Functional classification is the process by which all roadways are grouped into classes according to the type of service they provide. The Federal Highway Administration (FHWA) requires the use of functional classification to determine eligibility for federal funding. There are three principal roadway classifications: arterial, collector, and local roads. To be eligible for Surface Transportation Block Grant – Suballocated (STP-S) funds, a roadway must be classified as a minor collector or higher in an urban area or a major collector or higher in a rural area.

In order to accurately reflect changes in land use and travel patterns, staff, along with the Missouri Department of Transportation (MoDOT) and the Illinois Department of Transportation (IDOT) solicits revision applications from member agencies semi-annually and conducts a full system review every three to five years. County and municipal officials submitted applications requesting functional class changes to East-West Gateway in November of 2023. Staff worked with MoDOT, IDOT and local officials to prepare this update.

The applications were reviewed in the context of FHWA guidelines including mobility, accessibility, and connectivity. Requested changes are recommended where it is deemed that a road's current classification is no longer consistent with its function. Sometimes, current conditions do not support a change in classification as requested.

At this time, a total of 10 changes in Missouri and one change in Illinois are recommended to the system. Two applications are not recommended because they do not meet the criteria for a change in classification at this time. A list showing the recommended changes is included in this memo. Once approved by the Board of Directors, updates will be sent to MoDOT and IDOT headquarters for final review and subsequent submittal to FHWA for final approval.


