1. Introductions

Jacque Knight called the meeting to order at 2:03 p.m.

2. Approval of Minutes from Previous Meeting – November 8, 2023

The minutes were approved as proposed.

3. Elections – Chair, Vice Chair, and TPC Representatives

John Kohler made the motion to approve and Travis Wood seconded the motion.

4. Great Streets Plans to Pilots Initiative

Christie Holland presented an overview and timeline for the Great Streets Plans to Pilots Initiative, which is funded through a grant from the Healthy Illinois MPO Collaborative. Walk audits are currently being conducted to assess challenges and opportunities in target locations. Discussion on barriers to implementation touched on the following issues: resistance to new/innovative/interim treatments, the cost of large-scale projects versus quick builds, concerns over anticipated maintenance, working within the existing right-of-way, incremental change, the benefits of demonstration projects, and guidance released by MARC and MNDOT.

5. **St. Louis County Upcoming Projects**

John Shrewsbury shared several road projects currently in design that will include shared-use paths and sidewalks, including implementation of the West Florissant Great Streets plan. Further detail on upcoming projects can be found on the St. Louis County website.

6. **St. Charles County BikeWalk Phase 1**

Sara Nelson provided an update on the BikeWalk Phase 1 project that was awarded TAP funding last year. The project moves forward implementation of the August 2021 update to the Gateway Bike Plan and includes improvements on three routes – West Meyer Blvd, Lake St. Louis Blvd, and Interstate Drive. Improvements across 18 miles of facilities include upgrading sections to ten foot wide shared-use path, wayfinding and signage, pavement markings, crosswalks, pedestrian signals, and RRFBs. A public meeting for the project was held January 31, 2024 and construction will begin by Spring 2026. More information for the projects is available online at www.Sccmo.org/BikeWalk.

7. **Baltic Creek Greenway**

Mark Vogl presented on the Baltic Greenway in St. Charles County that will connect the Dardenne Greenway to the Katy Trail. The greenway also creates connections to St. Charles Community College, Vantage Park, and Veteran's Tribute Park, which were prioritized in the 2020 St. Charles County Greenway Master Plan. Public engagement generated the name for the new greenway and planning has narrowed the alignment down to two options – either on Caulk's Hill Road or Pitman Hill Road.

8. **Safe Streets and Roads for All (SS4A)**

Rachael Pawlak announced that work is proceeding on the region's comprehensive safety action plan, which has been titled "Gateway to Safer Roadways". The plan is expected to be complete in June 2024 so that local public agencies are able to apply for implementation funds this year. The USDOT has not released the FY 2024 SS4A NOFO, therefore the deadline to submit funding request for implementation projects is speculative and based on previous deadlines. Data analysis is underway and is looking at vulnerable road users, contributing crash factors, and underserved communities, as well as development of the high injury network. Task force meetings kicked off at the end of January and the next round of meetings is coming up in a couple weeks.

9. **Federal Funding Project Submittals**

Alex Hartig announced that applications for STP-S/BRO and CMAQ/CRP were due last week, on February 8. In Missouri, 65 STP-S and 17 CMAQ applications were submitted. In Illinois, 23 STP-S and 8 CMAQ applications were submitted. The number of applications received is slightly lower than last year, but still about average. Applications are still being processed, so the amount of federal funds requested is not yet available. There will be an online public comment period for the submitted projects from March 12-28.

10. **Coordinated Human Services Transportation Plan (CHSTP)**

Melissa Theiss shared the schedule of open houses and public comment period for the draft CHSTP that was released earlier this month. The final CHSTP will be presented to the EWG Board of Directors in April for approval and adoption.
