CALL TO ORDER

The Executive Advisory Committee was called to order by Ms. Williams, Chair, with roll call attendance.

APPROVAL OF MINUTES OF THE MARCH 19, 2024 MEETING

Motion was made by Mr. Courtway, seconded by Mr. Lamb, to approve the minutes of the March 19, 2024, meeting. Motion carried, all voting aye.

DISCUSSION ITEMS

FY 2024 Reasonable Progress Update – March 2024

Jason Lange, EWGCOG, provided the committee with a Reasonable Progress report. Mr. Lange reminded the committee of the EWG policy on providing updates on projects funded through the local programs. Mr. Lange provided a brief background of the Reasonable Progress policy, how it applies to local sponsors, and an update on current project sponsors.

East-West Gateway's Policy on Reasonable Progress ensures local projects maintain their proposed schedules. Projects in the Transportation Improvement Program (TIP) are considered to have made "reasonable progress" when the federal funds programmed for the project are obligated in the fiscal year they are programmed. Failure to meet this policy will result in the loss of federal funds. Mr. Lange noted that reasonable progress is tracked only for projects in Missouri. Project sponsors may request a one-time extension. The project extension process takes place each June and will be presented to the EWG Board of Directors for consideration and approval.

Mr. Lange noted that MoDOT is requiring EWG to obligate \$99 million of Federal funds during FY 2024. Failure to meet this amount would mean the EWG region would lose Federal funding for local projects. EWG frequently communicates with sponsors via a monthly spreadsheet tracker and as needed project follow-up.

EWG staff have been monitoring projects in the current fiscal year, which ends on September 30 and for future fiscal years. As of March 31, 2024, there are 164 local projects in Missouri with federal funding programmed in FY 2024 of the FY 2024-2027 TIP. These projects, sponsored by 50 different agencies and representing \$124.5 million in federal funds, are subject to the September 30 deadline unless noted as already receiving a schedule extension from the prior fiscal year.

As of March 31, nearly \$11 million in Federal funds have been obligated and two projects have advanced from a future year to the current year. Mr. Lange noted that this number is expected to increase. Because of the gravity of the situation, EWG will frequently report on progress.

ACTION ITEMS

Approval of the FY 2025 Unified Planning Work Program (UPWP) and Authorization to Enter into Agreements for Work Identified in the UPWP

Jim Wild, EWGCOG, provided the committee with the final FY 2025 Unified Planning Work Program (UPWP) document, noting that the draft had been provided to the Board in March for review. The UPWP describes all of the planning work activities that EWG and other local agencies will undertake during the 12-month period that begins July 1, 2024. This document serves as the scope of work for our grant agreements with the state and federal agencies that provide funding to support EWG's planning and related activities in the region.

The UPWP was distributed and reviewed by EWG funding agencies, and made open for public comment from March 8, 2024 through April 9, 2024. During that period, EWG received

comments from the Federal Highway Administration regarding formatting, adding information to the Planning Emphasis Areas (PEAs), and examples of regionally significant research projects. These corrections were addressed and implemented. Additionally, in work element 2.13, the funding table was updated to include MoDOT's funding in the Total section.

Mr. Wild noted Section II of the UPWP, which included the funding tables that describe the sources of funds and estimated costs for the planned activities. The total funding projected for FY 2025 is about \$15.2 million, with \$8.9 million estimated for new funding during the fiscal year. EWG's in-house costs are estimated to be \$7.3 million and we estimate that \$3.4 million will be expended to hire consultants for planning projects completed during the fiscal year, and \$3.8 million will be passed through to or expended on behalf of other local agencies.

Staff recommends approval of the proposed FY 2025 UPWP and that the Executive Director be authorized to negotiate and execute the funding agreements, grant agreements, and financial assistance sub-awards that are necessary to complete the work that is outlined in the document.

Motion to recommend board approval of staff's recommendation was made by Mr. Etling, seconded by Ms. Nelson. Motion carried, all voting aye.

Inflationary Adjustment Policy - MO LPA Program

Marcie Meystrik, EWGCOG, presented the committee with an Inflationary Adjustment policy. Ms. Meystrik explained that MoDOT's FY 2024 goal for each Transportation Management Area (TMA) is to obligate 120% of its annual allocation, which is approximately \$108 million for East-West Gateway. In addition to this goal, there is also a "trigger point" where if the obligation percentage falls under 110% (or \$99 million for East-West Gateway) at the end of the fiscal year, the funds will expire from the local program and be obligated on the state program.

Ms. Meystrik noted that there is currently \$124 million programmed in FY 2024. She added that based on EWG staff's best estimates, the total federal cost of projects expected to obligate in FY 2024 is around \$98 million, which is slightly below the trigger point. Any unforeseen circumstances or project delays could mean that LPA funds would expire. Staff is proposing a policy that would assist in meeting that trigger point.

Ms. Meystrik reported that earlier this month, the Missouri Transportation Planning Committee (TPC) recommended the approval of a temporary measure to increase funding for projects experiencing inflationary issues. This includes utilizing up to \$10 million before the end of the calendar year (December 31, 2024) or when the money is fully expended. The \$10 million figure represents roughly the difference between the 110% and 120% obligation targets. There would be no fiscal impact on FY 2024 projects, but using these funds for this purpose may result in less funding in later years, depending on project dropouts and extension requests. Ms. Meystrik then presented the parameters approved by the Missouri TPC for this temporary measure. Moving forward, projects that receive this increase will be reported on in future meetings.

A discussion between the committee and EWG staff was had over adjusting the deadline for funds to be obligated by and adding a cap to the funds each project can receive. The two revisions decided by the committee and EWG are as follows:

- Approval will be issued first-come, first-served, and the construction funds must be obligated by September 30, 2024 and Bid Concurrence must occur prior to December 31, 2024.
- The amount for each eligible project will be no less than \$50,000 federal, and no more than \$1,000,000 federal, or 30% over the original estimate in the TIP application, whichever is lowest.

Mr. Greifzu motioned to recommend board approval of the staff's recommendation with two amendments. The motion was seconded by Mr. Courtway. Motion carried, all voting aye.

Approval of the Coordinated Human Services Transportation Plan (CHSTP)

Melissa Theiss, EWGCOG, provided the committee with the final Coordinated Human Services Transportation Plan (CHSTP). Ms. Theiss noted that the CHSTP is a regional planning tool designed to guide the investment of Federal Transit Administration (FTA) Enhanced Mobility of Seniors and Individuals with Disabilities (Section 5310) funding. The Section 5310 program is a relatively small program with about \$2.9 million annually, and the CHSTP helps use those funds strategically.

In accordance with Federal law, the CHSTP must be updated at least every four years and should include four key elements: 1) an inventory of existing transportation services in the St. Louis region, 2) an assessment of the transportation needs of seniors and individuals with disabilities, 3) strategies to address the gaps between existing services and the needs assessment, and 4) priorities for implementing the identified strategies.

This CHSTP update was developed with assistance from stakeholders and agencies across Missouri and Illinois last fall. The draft CHSTP was presented to the TPC, EAC, and Board of Directors in February 2024 and was open for public comment from March 1 through March 31. Open houses for the draft CHSTP were held in person and virtually in March 2024. The update identifies five gaps or areas of unmet needs: Affordability, Reliability, Coordination, Environmental and Social, and Technology. It also identified 31 strategies that can be implemented in the region to help address and mitigate these gaps. Ms. Theiss noted that more details are provided in chapter 6 and page 42 of the CHSTP.

Motion to recommend board approval of staff's recommendation was made by Mr. Lamb, seconded by Mr. Jemison. Motion carried, all voting aye.

Functional Classification Update

Ben Fleschert, EWGCOG, provided an update on the Functional Classification project. This update was prepared in collaboration with MoDOT, IDOT, local officials, and EWG.

Mr. Fleschert briefly described the requirements and process by which all roadways were grouped into classes according to the types of service provided to determine eligibility for federal funding. He noted that staff, along with the MoDOT and IDOT, actively solicit applications from member agencies semi-annually and conduct a full system review every three to five years.

County and municipal officials submitted applications requesting functional class changes to East-West Gateway in November 2023, during which EWG received 13 new applications and recommended 11 changes. A list detailing the recommended changes was included in the memo. Once approved by the EWG Board of Directors, the update will undergo a final review at MoDOT and IDOT headquarters and subsequent submittal to FHWA for final approval.

Motion to recommend board approval of staff's recommendation was made by Mr. Etling, seconded by Mr. Doucleff. Motion carried, all voting aye.

Modifications to the FY 2024-2027 Transportation Improvement Program, Connected 2050, and the Related Air Quality Conformity Determination – Requested by Illinois and Missouri Sponsors

Jason Lange, EWGCOG, informed the committee that The Illinois Department of Transportation (IDOT) and the Missouri Department of Transportation (MoDOT) have requested to amend the FY 2024-2027 Transportation Improvement Program (TIP). They are requesting to add one new project, modify two projects, and add one new engineering-only project. Mr. Lange gave a brief overview of the requests, which can be found in the memo.

Motion to recommend board approval of staff's recommendation was made by Mr. Etling, seconded by Mr. Doucleff. Motion carried, all voting aye.

Subject: Draft Gateway to Safer Roadways: Saint Louis Regional Safety Action Plan

Date: May 14, 2024

The Council applied for and received a planning grant to develop a Comprehensive Safety Action Plan for the St. Louis region through the U.S. Department of Transportation's (USDOT) FY 2022 Safe Streets and Roads for All (SS4A) program as part of the Infrastructure Investment and Jobs Act. The Comprehensive Safety Action Plan, named *Gateway to Safer Roadways: Saint Louis Regional Safety Action Plan* (Action Plan) covers the entire eight-county region and will enable any county or municipality in the region to apply for SS4A's Planning and Demonstration Grants in 2024, 2025, and/or 2026 or Implementation Grants in 2025 and/or 2026.

The Regional Safety Task Force and five county stakeholder groups were instrumental in the development of the Action Plan. Both the Task Force and the stakeholder groups met three times for a total of 18 meetings and helped inform the development of the plan.

The Action Plan includes the following:

- A target to reduce the number of fatalities and serious injuries caused by roadway crashes in the EWG Region by 50 percent by 2050.
- Regional High-Injury Networks (All Modes, Vulnerable Road Users, Underserved Communities, Top Contributing Factors, and Interstates).
- High-Injury Networks for each county in the St. Louis Region.
- Near and long-term strategies focused on USDOT's Safe System Approach, including proven safety countermeasures.
- In-depth review of local, state and national safety polices, concepts and resources. Calls
 out the strengths in local and state policies and programming as well as needs and
 opportunities.
- Unified branding to ensure consistent communication across the Region.
- A method to measure progress.

The CBB team will present the draft Action Plan at this month's Board of Directors meeting. At the June meeting, the Council will seek final approval of the Action Plan and a commitment to the eventual goal of zero roadway fatalities and serious injuries by setting the target of 50 percent reduction in roadway fatalities and serious injuries by 2050. After the plan is approved, projects that align with the plan will be eligible to apply for funding through the SS4A program.

Subject: FY 2024 Reasonable Progress Update – April 2024

Date: May 14, 2024

East-West Gateway's (EWG) Policy on Reasonable Progress ensures that projects funded through the local programs (i.e., Surface Transportation Block Grant Program, Congestion Mitigation and Air Quality Improvement Program, Carbon Reduction Program, and Transportation Alternatives Program) maintain the schedule as proposed in the project application. For projects or programs included in the Transportation Improvement Program (TIP), "reasonable progress" will have been made if the project has advanced to the point of obligating all federal funds programmed for that project in the current fiscal year (FY), regardless of phase of work (i.e., Preliminary Engineering (PE), Right of Way Acquisition (ROW), or Construction (CONST)). Failure to meet the Policy will result in the loss of federal funds for the project. Reasonable Progress is tracked for projects in Missouri only.

If a project is realizing delays that will put the federal funding at risk of forfeiture (i.e., will not meet the September 30th deadline), the project sponsor has the opportunity to request consideration of a one-time extension in their project schedule. This process takes place each June. One-time extensions of up to three months may be granted by EWG staff and one-time extensions greater than three months, but not more than nine months, are presented to the EWG Board of Directors for consideration and approval.

As of April 30, 2024, there are 169 local projects in Missouri with federal funding programmed in FY 2024 of the FY 2024-2027 TIP. These projects, sponsored by 51 different agencies and representing \$138 million in federal funds, are subject to the September 30th deadline unless noted as already receiving a schedule extension from the prior FY.

In April 2024, the Board of Directors approved a temporary measure to increase funding on projects that are experiencing inflationary issues. To date, no adjustments have been administered.



Policy on Reasonable Progress

In the past, the lack of progress in developing and implementing projects using federal funds suballocated to the St. Louis region has led to significant project delays and created financial risks for both local and state transportation programs. Over the last several years, the East-West Gateway Council of Governments (EWGCOG) has taken a firm stance on delinquent projects through enforcement of the Council's Policy on Reasonable Progress.

Currently, there are 169 local projects in Missouri with federal funding programmed in Fiscal Year (FY) 2024 of the FY 2024-2027 Transportation Improvement Program (TIP). These projects, sponsored by 51 different agencies and representing \$138 million in federal funds, are subject to a September 30, 2024 deadline to obligate the federal funds, unless noted as receiving a schedule extension. To obligate funds, a sponsor must obtain approval from the Missouri Department of Transportation (MoDOT) for a specific milestone. Generally, a project must meet three milestones before construction or implementation of a project may begin: approval of design contract (PE), approval to acquire right of way (ROW), and final plan approval/authority to advertise (CONST/IMPL).

If a project is realizing delays that will put the federal funding at risk of forfeiture (i.e., not meet a September 30 deadline), the project sponsor will have the opportunity to request a "one-time extension" of their project schedule. The request for an extension is only available for projects with construction funds programmed in the current fiscal year and is due by June 1, 2024. One-time extensions of up to three (3) months may be granted by East-West Gateway staff and one-time extensions greater than three (3) months, but not more than nine (9) months, will go to the Board of Directors for their consideration and approval. If the project still cannot obligate funds after the one-time extension or the sponsor decides not to proceed, funding will be removed from the TIP, and the federal funds associated with those projects will be returned to the regional funding pool for redistribution without further action by the board.

EWG included Carbon Reduction Program (CRP) funding as part of the CMAQ solicitation and Missouri Off-System Bridge Program/Bridge Formula Program (BRO/BFP) funding as part of the STP-S solicitation. The project applications were due on February 8, 2024.

Staff has completed the evaluation of local project applications, and the Transportation Planning Committees (TPC) in Illinois and Missouri made funding recommendations at their May meetings.

The Illinois TPC recommended funding eight CMAQ/CRP project applications totaling \$6.1 million in federal funds (including \$4.4 million of CMAQ funds and \$1.7 million of CRP funds), and eleven STP-S project applications totaling \$8.5 million in federal funds.

The Missouri TPC recommended funding 18 CMAQ/CRP project applications totaling \$48.6 million federal funds (including \$37.8 million in CMAQ funds and \$10.7 million in CRP), 28 STP-S project applications totaling \$66.7 million in federal funds, and five BRO/BFP applications totaling \$6.6 million in federal funds.

Subject: Illinois CMAQ Program – Approval of Surplus CMAQ Funding

Date: May 14, 2024

At their meetings earlier this month, the Illinois Transportation Planning Committee (IL TPC) approved project recommendations for the 2025-2028 Transportation Improvement Program (TIP). As part of that discussion, each of the county-level TPC's and the full IL TPC voted to recommend that the \$2 million surplus of CMAQ funds should be divided evenly between St. Clair and Madison counties to offset project cost increases on CMAQ projects that have been stalled due to funding issues. The surplus exists because there was more CMAO funding available this year than projects submitted. Staff has encouraged Illinois local project sponsors to submit more projects in future solicitations.

The parameters for the allocation of the surplus CMAQ funds would be as follows.

- Funds will be applied upon project receiving contractor bids (not based on engineer's estimate)
- Funds will only be available for local projects previously approved for CMAQ funding. Eligible projects are listed in Attachment A entitled, "CMAQ Infrastructure Projects Not Yet Accomplished," which was updated on 04/26/2024.
- Funds are for construction only (not construction engineering)
- Additional funding granted only for items in the application scope
- The increase is based on the federal matching percentage (for construction only) provided by the sponsor in the TIP application, not the rate in the program agreement
- \$1 million for Madison County and \$1 million for St. Clair County
 - For Madison County -
 - Approval is first come, first served
 - Additional funds provision ends when the \$1 million is committed
 - In the event there are multiple projects on the same letting, the funds would go to the oldest approved project
 - Construction funds must be obligated by December 31, 2024
 - For St. Clair County
 - Approval is first come, first served
 - Additional funds provision ends when the \$1 million is committed
 - One sponsor cannot receive more than \$500,000 in additional funds per project
 - In the event there are multiple projects on the same letting, the funds would go to the oldest approved project
 - Construction funds must be obligated by December 31, 2025

Staff has worked with IDOT Local Roads staff, and Madison and St. Clair counties to develop a process for the allocation of these funds. This process will be shared with Illinois local project sponsors upon adoption of the recommendation by the Board of Directors.

Staff Recommendation: Staff recommends the adoption of the recommendation by the Illinois Transportation Planning Committee to apply \$2 million of surplus CMAQ funds (\$1 million to be used in Madison County and \$1 million to be used in St. Clair County) to approved CMAQ projects that have been stalled due to cost increases. The funds would be allocated according to the parameters outlined in this

Subject: Regional Security Expenditures

Date: May 14, 2024

Staff is requesting authorization to expend funds in support of regional security that will improve the region's disaster preparedness and response capabilities. Funding will come from the U.S. Department of Homeland Security's Urban Area Security Initiative (UASI) grant program as well as STARRS Hospital Donation funds. Attachment A summarizes the purchases, totaling \$303,745.

ST. LOUIS FUSION CENTER and STARRS:

AT&T Mobility FirstNET Services - Staff is seeking approval for the renewal of AT&T Mobility FirstNET services for the St. Louis Fusion Center. The FirstNET voice/data network is a Federal government initiative to provide a dedicated mobile voice/data network for first responders such as law enforcement, fire, EMS, and emergency management. As FirstNET is dedicated to first responder usage, FirstNET has priority over all other mobile phone users. FirstNET users have priority in mobile congestion scenario, and provides 5G connection speeds for data in the St. Louis region, which is imperative to the anti-terrorism functions of the St. Louis Fusion Center as staff must be reachable at all times to assist Federal, State and Local law enforcement entities with investigations and information / data collection and dissemination. The procurement includes the renewal of services for 24 months for seven (7) mobile phone devices and 13 hotspot devices, for an amount not to exceed \$22,000 from the UASI grant program.

In addition, Staff is requesting to renew the services for the six (6) FirstNET mobile phone devices currently utilized by STARRS staff. The devices allow STARRS staff to perform work-related functions away from the office environment, as they are able to utilize them in the field, when working from local Emergency Operations Centers, or performing duties outside of the region. The total cost for renewal of services for 24 months will not exceed \$8,250. Funding will come from STARRS Hospital Donation funds.

REGIONAL RESPONSE TEAMS:

Respiratory Equipment Masks for Law Enforcement - Staff is seeking approval to purchase quantity twenty (20) Avon FM54 respiratory equipment masks for the Franklin County Sheriff's Department. The masks provide protection against chemical and biological agents as well as toxic industrial materials with a chemical agent resistance of greater than 36 hours. In addition to offering respiratory protection, the masks allow tactical team members to communicate with each other during a response through electronics communications ports for integrated voice projection and radio communications. The total cost for twenty (20) respiratory equipment masks will not exceed \$38,495 from the UASI grant program.

Chemical Identification Analyzers for Hazardous Materials Response Teams – Staff is seeking to purchase quantity two (2) Thermo Scientific Gemini chemical identification analyzers for two (2) of the region's hazardous materials response teams, the City of St. Louis Fire Department and the St. Clair Special Emergency Services Association. The analyzers are able to identify a broad range of unknown chemicals and explosives in the field in a single instrument, assisting teams in executing missions and deployments in a safe and accurate manner. The total cost for two (2) chemical identification analyzers will not exceed \$235,000 from the UASI grant program.

STAFF RECOMMENDATION:

Staff recommends that the Board approve the expenditure of funds as follows:

- for the renewal of FirstNet services for seven (7) mobile phone devices and 13 hotspot devices for 24 months for the St. Louis Fusion Center from AT&T Mobility FirstNET of Carol Stream, IL in an amount not to exceed \$22,000;
- for the purchase of 24 months of services for the six (6) FirstNET mobile devices utilized by STARRS Staff from AT&T Mobility FirstNET of Carol Stream, IL in an amount not to exceed \$8,250;

- for the purchase of quantity twenty (20) Avon FM54 respiratory equipment masks for the Franklin County Sheriff's Department from Con10gency Consulting of Selma, TX for an amount not to exceed \$38,495;
- for the purchase of two (2) Thermo Scientific Gemini chemical identification analyzers for the City of St. Louis Fire Department and St. Clair Special Emergency Services Association from Thermo Scientific of Tewksbury, MA for an amount not to exceed \$235,000;

for a total amount not to exceed \$295,495 from the UASI grant program, and \$8,250 from STARRS Hospital Donation funds.
